Concurrent Enrollment NON-BGSU SEVIS Student

Students can maintain F-1/J-1 visa status by completing courses concurrently at another university or college while remaining on their current institution's Form I-20 if they meet all the requirements listed on this 'Concurrent Enrollment' form.

Procedures

- 1. Before enrolling concurrently, verify with an academic advisor at your current institution that the concurrent courses meet your degree requirements and that the courses will transfer to your specific degree program.
- 2. Submit your immigration documents and this form to iss@bgsu.edu
- 3. Enroll and complete the concurrent courses.
- 4. Submit your transcript from BGSU to the university/college that holds your immigration record.
- 5. Arrange for the transfer of credit by the first day of class of the following semester.
- 6. Remember that you must complete this process every semester you wish to enroll concurrently.

NOTE: Consult other campus offices to determine if using your credit hours at BGSU for your degree program at your current institution will affect your scholarships, ITA/RA positions, and campus housing.
