Prerequisite: Military Science 102 or veteran with minimum of six months active duty. Laboratory fee, \$2 each semester. Staff.

301-302.* MILITARY SCIENCE AND TACTICS III. First Year Advanced. 3 each semester; I, II. Leadership, drill, and exercise of command; tactics and technique of field artillery; tactics and technique of antiaircraft artillery; gunnery; supply; evacuation. Prerequisite: Military Science 202 or veteran with 12 months or more active duty. Laboratory fee, \$2 each semester. Staff.

401-402.* MILITARY SCIENCE AND TACTICS IV. Second Year Advanced. 3 each semester; I, II. Military administration; military law and boards; military teaching methods; psychological warfare; branch tactics and technique; tactics and technique of antiaircraft artillery; geographical foundation of national power; leadership, drill, and exercise of command. Prerequisite: Military Science 302. Laboratory fee, \$2 each semester. Staff.

104.* HARMONY. 2; II. Four-part writing; harmonic dictation; keyboard. Prerequisite: Music 103 or equivalent. Parallel: Music 102. Mr. Benstock.

107.* ELEMENTARY CONDUCTING AND TERMINOLOGY. 1; I. Basic terms and signs; fundamental conducting techniques. Mr. Benstock, Mr. Glasmire.

108.* INTERMEDIATE CONDUCTING AND TERMINOLOGY. 1; II. A continuation of Music 107. Prerequisite: Music 107. Mr. Benstock, Mr. Glasmire.

201.* SIGHT SINGING AND EAR TRAINING. 2; I. Prepared and sight-reading of advanced choral material; melodic and harmonic dictation. Prerequisite: Music 102. Mr. Alexander.

202.* SIGHT SINGING AND EAR TRAINING. 2; II. A continuation of Music 201. Prerequisite: Music 201. Mr. Alexander.

205.* HARMONY. 2; I. Nonharmonic tones; altered chords; modulations; harmonic counterpoint. Three hours a week. Prerequisite: Music 104 or equivalent. Miss Jensen.

206.* HARMONY. 2; II. A continuation of Music 205. Three hours a week. Prerequisite: Music 205. Miss Jensen.

211. GENERAL MUSIC. 2; I, II. Fundamental music skills; reading by syllable; pitch and rhythm dictation; music appreciation; song singing. Four hours a week. Not open for credit to music majors or minors. Staff.

212. GENERAL MUSIC. 2; II. A continuation of Music 211. Four hours a week. Prerequisite: Music 211. Not open for credit to music majors or minors. Staff.

301.* CHORAL LITERATURE. 1; II. Reading and study of sacred and secular choral music from 16th to 20th century. Two hours a week. Prerequisite: Music 202. Mr. Allen.

303.* COUNTERPOINT. 2; I. Simple counterpoint; analysis of works of 16th century contrapuntists; use of modes and imitation. Prerequisite: Music 206 or equivalent. Miss Jensen.

304.* ANALYSIS OF FORM. 2; II. Analysis of the larger forms of musical composition. Prerequisite: Music 206 or equivalent. Miss Jensen.

305.* HISTORY OF MUSIC. 3; I. General course; readings, reports, and recorded music; survey of all periods. Miss Jensen.

306.* HISTORY OF MUSIC. 3; II. A continuation of Music 305. Miss Jensen.

309.* MODERN MUSIC. 2; offered on demand. An analysis course in recent and contemporary music. Prerequisites: Music 304, 306. Miss Jensen.

311.* CHORAL LITERATURE. 1; offered on demand. Reading and study of cantatas, oratorios, and other choral compositions, classical and modern. Two hours a week. Prerequisite: Music 202. Mr. Allen.

315.* INSTRUMENTATION. 2; I. Instrumentation and scoring for orchestral and band ensembles and full groups. Mr. Benstock.

316.* COMPOSITION. 2; offered on demand. Original composition in songs and instrumental forms. May be repeated once for credit with consent of Chairman of the Music Department. Prerequisite: Music 304. Mr. Kennedy.

317.* MUSIC APPRECIATION. 2; I, II. Enjoyment and understanding of music; hearing, lecture, and readings. Not open to special music students or to those having credit for Music 305 or 306. Laboratory fee, \$2. Mr. McEwen.

318.* SYMPHONIC LITERATURE. 1; I. A hearing course in the larger standard instrumental works. Intended primarily for students majoring in music. Prerequisite: Music 205. Prerequisites or parallels: Music 305, 306. Laboratory fee, \$2. Miss Jensen.

319.* SYMPHONIC LITERATURE. 1; offered on demand. A continuation of Music 318. Laboratory fee, \$2. Miss Jensen.

320.* BAND ARRANGING. 2; offered on demand. Scoring for band, choir, ensembles, and full band. Mr. Weger.

352. METHODS IN MUSIC APPRECIATION. 2; I. The basis of music appreciation; subject matter and methods; preparing and teaching typical lessons. Mr. McEwen.

355. METHODS IN SECONDARY MUSIC. 2; offered on demand. Subject matter and materials for music in junior and senior high schools. Prerequisite: Education 309. Mr. Fauley.

357. INSTRUMENTAL ORGANIZATION AND ADMINISTRATION. 2; II. For elementary and secondary schools. Mr. Weger.

COURSES IN APPLIED MUSIC

CREDIT REQUIREMENT. Twenty-seven to twenty-nine semester hours of applied music are required for students in public school music. All courses in applied music, including Music 100, 200, 300, may be used to meet this requirement.

INSTRUCTION. Study in applied music is offered in piano, voice, organ, and all orchestral and band instruments. All students enrolling in applied music courses for the first time are required to take a placement examination during registration week for purposes of classification based on ability and previous training. Studio class recitals will be held from time to time as deemed necessary by the instructor. Applied music students must pass satisfactorily an examination before a faculty committee at the end of the semester in order to receive full credit.

RECITAL ATTENDANCE. Students majoring in music are required to attend a minimum of 12 concerts a semester. This includes student and faculty recitals and concerts, and the University Artist Series. For less than 12 concerts attended, one-half hour of general credit will be deducted from the student's total credit hours; for less than 7 concerts attended, one hour of general credit will be deducted.

MAJOR REQUIREMENTS. Students majoring in piano must have sufficient performing ability to begin with Music 261 or higher and must complete Music 364 for graduation. Students majoring in voice must complete Music 374 for graduation. Those majoring in violin must begin with Music 281 or higher and complete Music 388 for graduation. Students majoring in brass instruments must begin with Music 231 or higher and complete Music 338 for graduation. Those majoring in woodwind instruments must begin with Music 241 or higher and complete Music 348 for graduation. Students majoring in percussion must complete Music 324 for graduation.

FEES

A fee of \$25 a semester is charged for each credit in applied music except courses designated "class." The schedule of fees for rental of instruments is as follows:
