A Resolution Formally Supporting a Tobacco Free Policy on The Bowling Green State University Campus

In the Senate of the Undergraduate Student Body here assembled,

1. **Whereas**, the Undergraduate Student Government represents the undergraduate student
2. voice at Bowling Green State University; and
3. **Whereas**, Bowling Green State University and the Undergraduate Student Government
4. aim to ensure all student voices are represented within the Senate; and
5. **Whereas**, the Undergraduate Student Government seeks to promote the health and well-being
6. of all students; and
7. **Whereas**, smoking is one of the largest causes of illness and premature deaths in the
8. United States and findings indicate that nonsmokers who are regularly exposed to tobacco
9. smoke are also at an increased risk of illness; and
10. **Whereas**, a policy regulating tobacco use on campus will promote student success,
11. decrease exposure to tobacco products and secondhand smoke, decrease exposure to new and
12. emerging tobacco and nicotine products, and eliminate tobacco product litter on campus; and
13. **Whereas**, Bowling Green State University is one of the only public university in Ohio to
14. have not supported and implemented similar tobacco and smoke-free policies; and
15. **Whereas**, a tobacco free policy would prohibit the use of all tobacco products on all
16. University grounds; and
17. **Whereas**, the policy would prohibit the use of cigarettes, e-cigarettes, cigars, chew,
18. pipes, hookah and any other nicotine vaporizing products, and
19. **Therefore let it be resolved that**, The Undergraduate Student Government of Bowling
20. Green State University formally supports a tobacco free policy to ban the use of tobacco
21. products on campus.
