Student Survey

A randomly generated list of 235 classes across all majors and departments on BGSU main Bowling Green campus was created by the Office of Registration and Records. E-mails were sent to every instructor asking permission to use less than 10 minutes of class time to invite the students to participate in an 8-item survey about smoking on campus. Graduate and undergraduate classes were included in the sample. Some classes in the sample only met online, met at the Levis Commons site, or were independent studies single students enrolled. Small classes, with as few as 4 students, were also given the opportunity to complete the survey.

In total, 38 classrooms participated in the study, for a total of 691 students across a variety of departments and majors.

Methods

Each class was given instructions read from a script to ensure consistent information provided between each room. Instructions and an informed consent document were also included as a cover page. Students were instructed to not complete the survey if they had already taken it in another class. Classes typically finished the survey within 4 minutes. The surveys were collected individually by hand and placed in a file folder. The completed surveys were immediately entered into the SPSS data set as aggregate data without labels for individual classrooms.

Student Results

The first three results are reported directly from the SPSS Output document for all participants, followed by filters controlling for relevant responses (e.g. interest in cessation services among those who identified as current smokers).

Conclusions (Students)

- 43% of all students believe that BGSU should definitely be smoke-free, 17.6% believe BGSU should be smoke-free as long as the university increases support for cessation programs, and 39.5% do not believe the university should be smoke-free.
- If the decision was made to allow smoking on campus with restrictions, the majority of students would prefer a policy with designated smoking areas (65.8%) rather than a perimeter policy (34.2%).
- The majority of current smokers (85.5%) do not believe BGSU should be smoke-free.
- Some current smokers (15.9%) choose not to smoke on campus.
- If the decision was made to allow smoking on campus with restrictions, current smokers would prefer a perimeter policy (79.7%) rather than a policy of designated smoking areas (20.3%).
- The majority of current smokers (62.3%) are not at all interested in cessation programs.
- Most current smokers interested in cessation programs (88.5%) are unwilling to help pay for the cost of the programs.
- 13% of current smokers are occasionally or frequently bothered by smoke at BGSU.
- 57% of students are frequently or occasionally bothered by smoke at BGSU.
- Among students who are frequently or occasionally bothered by smoke at BGSU, 64.2% believe that
 BGSU should definitely be smoke-free, 17.3% believe BGSU should be smoke-free as long as the
 university increases support for cessation programs, and 18.6% do not believe the university should be
 smoke-free in spite of being bothered by smoke on campus.
- If the decision was made to allow smoking on campus with restrictions, the majority of students who reported being frequently or occasionally bothered by smoke at BGSU preferred a policy of designated smoking areas (83.9%) over a perimeter policy (16.1%).
- Students who are frequently or occasionally bothered by smoke at BGSU reported eyes/nose/throat irritation (83%), concern for long term health (55.3%), and headaches (34.4%) as the primary ways they are bothered by smoking.
