

Executive Summary Fiscal Year 2008 (July 1, 2007 – June 30, 2008)





Top Ten Sources of Award Dollars FY 2008

From its top ten sources of grant dollars in FY 2008, BGSU received \$14,678,926, representing 82% of the annual total of award dollars which the institution received during the fiscal year. These 10 agencies provided BGSU with 84% of its research funding, 81% of its instructional/training funding, and over 76% of its public service funding for the fiscal period. Together, these agencies represent 86% of the federal grant dollars, 72% of private foundation funding, and 87% of state grant dollars.


