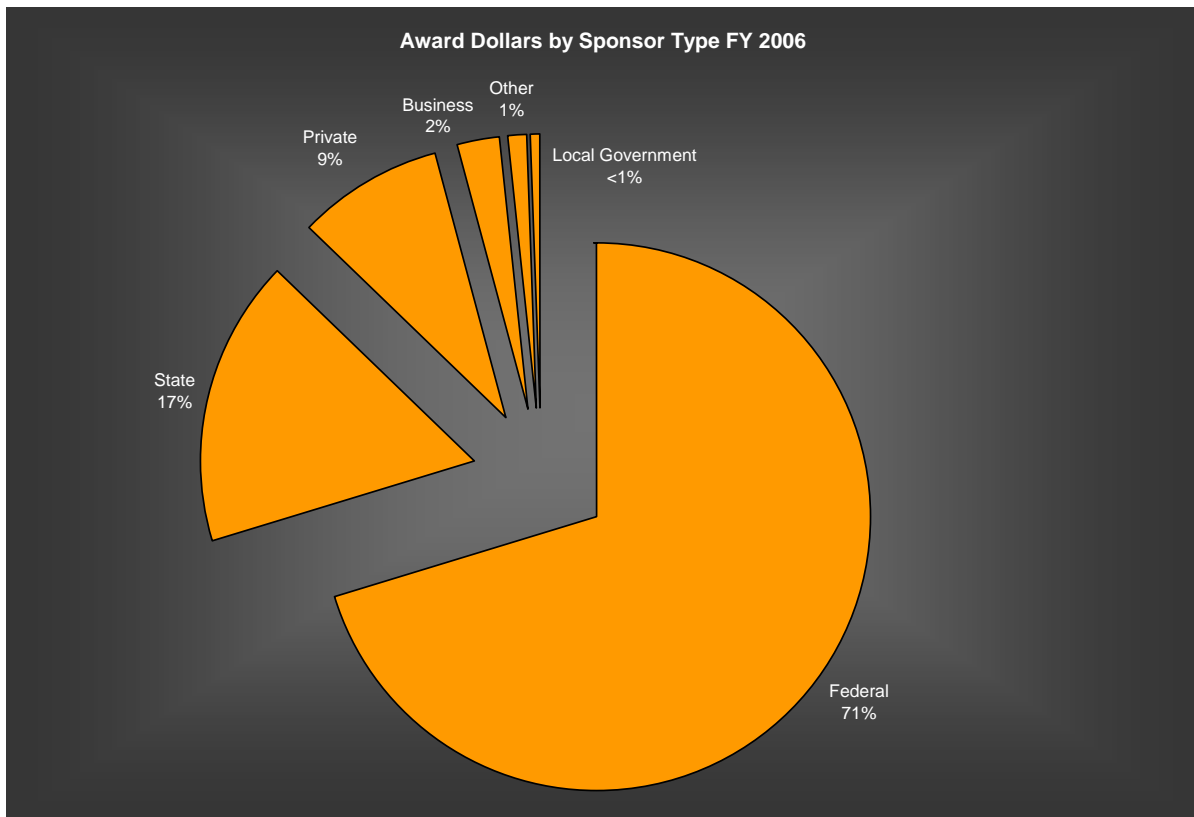

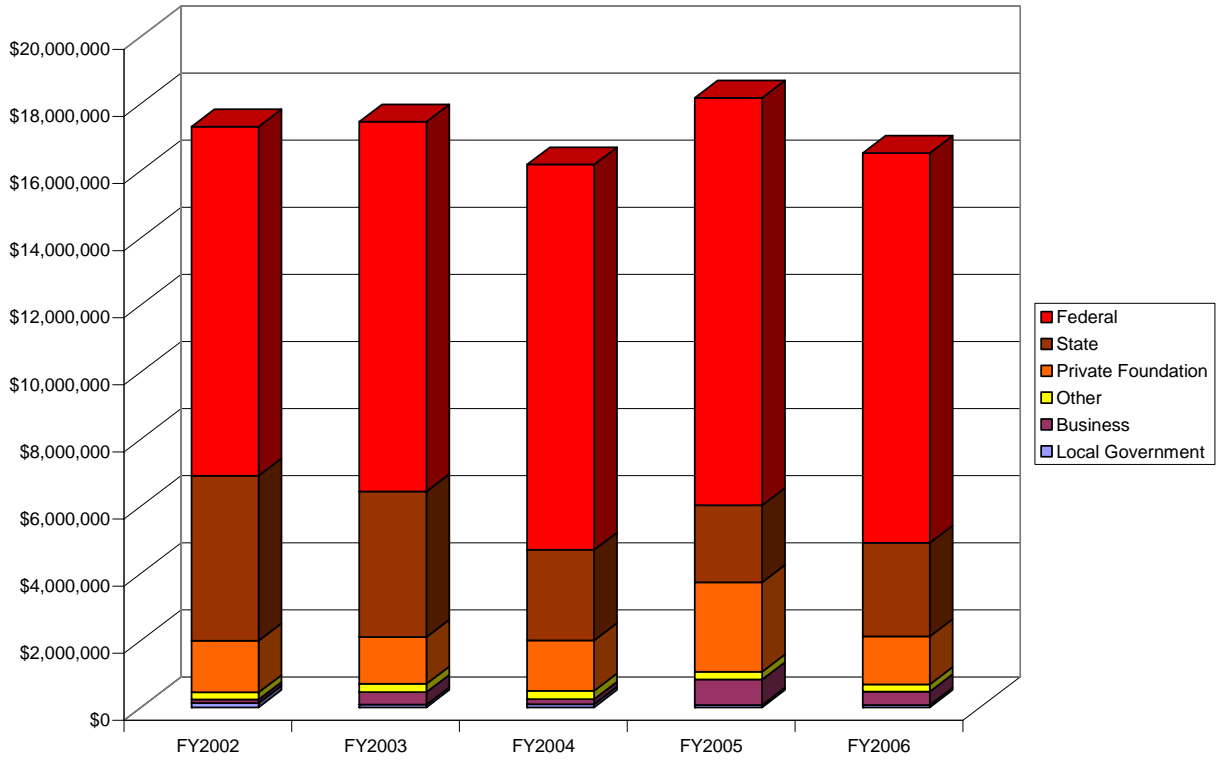
FY 2006 Award Dollars by Sponsor Type

Top Ten Sources of Award Dollars FY 2006

From its top ten sources of grant dollars in FY 2006, BGSU received \$13,257,987, representing just over 80% of the annual total of award dollars which the institution received during the fiscal year. These 10 agencies provided BGSU with 79% of its research funding, 87% of its instructional/training funding, and over 70% of its public service funding for the fiscal period. Together, these agencies represent 88% of the federal grant dollars, 59% of private foundation funding, and 77% of state grant dollars.

⁶ Subawards from University of Oklahoma and Dartmouth College provided \$84,307 of the total received from NASA.

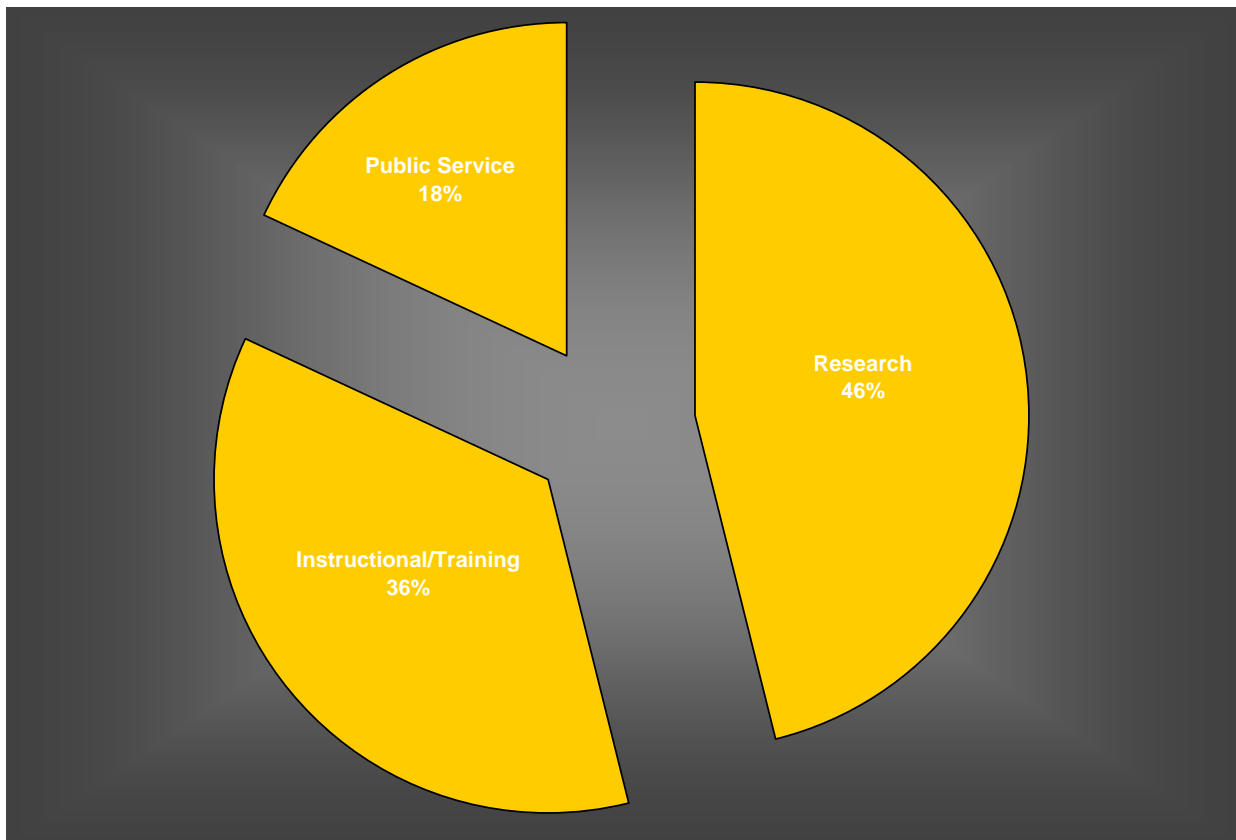
