 - Michele Schmitz (Budget Administrator)
- Ouestion and Answers:
 - Direct question to Dean Waldron from the President of GSS:
 - What drew you to the role of the Dean?
 - How can the GSS as a whole play a part in furthering the mission and vision of the university?
 - Answer:
 - She loves graduate education and her time at BGSU as a graduate student was life-changing.

- She believes in the accessibility of higher education which is practiced at BGSU. She also mentioned that some of her family members live in Bowling Green. For her, one way to contribute is by understanding the perspective of graduate students and advocating for them when their voice is not heard.
- Question directed to Alexia Coffman from the GSS President:
 - Asked to talk about her process when receiving an application for the Funds for Professional Development for graduate students.
 - Answer:
 - She said that it starts with the letter and instructions that she receives when the students are awarded funding which she reviews from time to time.
 - Expense reports are reviewed on Chrome River.
 - Strict requirements involved for reimbursement of travel, members, and training expenses.
 - Additional requirements may be required, and this leads to a lot of back and forth.
 - When certified, she signs and sends it to Michele Schmitz.
 - Michele Schmitz reviews it and sends it to Account Payable.
 - Account Payable reviews it and makes the payment.
 - Acknowledged that the entire process takes time and that students should be patient during the process.

 The GSS President asks about the importance of mental health for graduate students and creating a work-life balance.

Answer:

- Be intentional and committed about the simple things: eating, sleeping, and exercising. Plan your life properly.
- Have a team or a close confidant that can be of help to you.
- Reach out for help. This includes your close friends/confidant, senior faculty members, and the BGSU Counseling Center.
- Question directed to Michele Schmitz:
 - The GSS President asked Can you tell us how the graduate student's stipend is decided?
 - Answer:
 - The Graduate College is given a budget from the central administration, and it is divided into:
 - Assistantships/Personnel
 - Scholarship/Operations
 - The Graduate College further reviews and assesses the allocated budget based on:
 - Enrollment
 - Prior use of allocation
 - Admission rate
 - Based on this review different dollar amount is placed on each college.
 - Colleges review the allocated budget and make their own budgetary decision based on the allocated dollar amount per funding department.
 - Assistantships and scholarship rates are decided by the individual departments so long these

rates are within the pre-published range (available on the Graduate College website).

Open questions to the guest as regards common challenges they face during review and assessment of the FPD application?

• Michele Schmitz:

- Emphasized the need for students to follow instructions.

Alexia Coffman:

- Reiterated Michele Schmitz's comments. She further stated that it is important to know the difference between confirmation of purchase and proof of payment. With the former, no reimbursement will be made, however with the latter, proof of payment, there will be reimbursement.
- Question from the Representative of Sociology (Doctorate):
 - Asked when reimbursement for the FPD application in the summer be received?

Alexia Coffman:

- Hopefully next week; she is in the process of implementing ways to make the FPD process faster.
- Question from the Representative of Chemistry (Masters):
 - Why is there a stipend break in the summer and is there a possibility to equally distribute paychecks throughout the academic year?

Michele Schmitz:

 Stipend distribution is based on a standard payroll distribution, and it is only active when a student is still in contract. Payments cannot be

made when graduate assistants are not under an active contract.

- Question from the Representative of Curriculum and Teaching (Masters):
 - Does the Graduate College anticipate extending the GRE waiver? Why or why not?
 - Dean Waldron:
 - Stated that there are a lot of processes involved and that the Graduate College is embedded within a larger structure.
 - Some changes do not come from the Graduate College.
 - Dean Goberman:
 - Some departments have separate policies for GRE.
 - Historically, GRE has been required at the Graduate College level, however, they are in the process of waiving it. Although, it may still be a requirement for some programs.
- Question from the Representative of Curriculum and Teaching (Masters):
 - Will the Graduate College consider providing more indepth workshops on the process of conducting research for first-time graduate students?
 - Dean Waldron:
 - Yes, the Center of Faculty Excellence and Learning Community has certain programs organized for Teaching Assistants and Instructors to assist with such needs. She intends to find collaborative ways in which the Graduate College can assist in making these

workshops and training accessible to all graduate students.

- Question from the Representative of American Cultural Studies (Doctoral):
 - How are budget packages allocated to each department?
 - Dean Waldron:
 - Central Office determines the budget provided to the Graduate College.
 - Graduate College: Assistantship & Scholarship Reviews and analyze data based on enrollment, prior use of allocation, and admission rate.
 - Provost
 - Colleges reviews for each department
 - Departments/Programs allocate funds based on the number of students expected.
- Question from the Representative of American Cultural Studies (Doctoral):
 - Asked for clarification on the transparency of this process.
 - Michele Schmitz:
 - It is a very transparent process. The line items are in the proposed annual fiscal year budget which is done by the finance administration.
 - The remainder of the budget goes into service areas such as residence life.
- Question from the Representative of School Counseling and Clinical Mental Health Counseling:
 - Do we have to wait for departmental approval before applying for FPD funding?
 - Michele Schmitz:
 - No, you don't have to wait.

- Because of deadlines, it is advisable to apply for departmental funding and FPD funding.
 However, if you are awarded both, the precedent is to accept the one from your department and if there is a remainder, the funds from the GSS FPD can cover the outstanding amount.
- Question from the GSS Representative-At-Large:
 - Asked if there is any communication and collaboration between the Graduate College and department as regards FPD application – Are there different rules between the department and the GSS FPD for this application?
 - Michele Schmitz:
 - Every department handles allocation differently.
 However, all parties, the GSS FPD inclusive, must follow the rules of the BGSU Account Payable Department.
