A Resolution Formally Supporting and Implementing the Addition of a College Credit Plus Senator

In the senate of the Undergraduate Student Body here assembled,

1. **Whereas**, the Undergraduate Student Government represents the undergraduate student voice
2. at Bowling Green State University; and
3. **Whereas**, Bowling Green State University and the Undergraduate Student Government
4. aim to ensure all student voices are represented within the Senate; and
5. **Whereas**, over 2,020 students are currently enrolled in College Credit Plus courses through
6. Bowling Green State University; and
6. **Whereas**, current and incoming classes of students at Bowling Green State University have
7. college credit hours from high school; and
8. **Whereas**, these students may require a different academic, student life, and career
9. advising approach than other student demographics at BGSU; and
10. **Whereas**, differing circumstances may procure a different student point of view than that
11. which is currently represented in the Senate of the Undergraduate Student Government; and
12. **Whereas**, College Credit Plus students are students at Bowling Green State University; and
13. **Whereas**, the Undergraduate Student Government serves as the mouthpiece for the
14. undergraduate student body; and
15. **Whereas**, the Undergraduate Student Government and Bowling Green State University have
16. created representative positions to allow for student representation within the Senate
17. **Therefore, let it be resolved that**, the Undergraduate Student Government of Bowling
18. Green State University hereby formally supports the addition of an appointed High School
19. Student College Credit Plus Senator; and
20. **Therefore, let it further be resolved that**, the Governing Bylaws of the Undergraduate
21. Student Government Article III. Section A. Subsection 1. Subsection a. will be amended to
22. include one (1) senator seat for College Credit Plus; and

23. **Therefore, let it further be resolved that,** the Governing Constitution of the Undergraduate
24. Student Government Article IV. Section B. Subsection 1. will be amended to include
25. College Credit Plus; and

26. **Therefore, let it further be resolved that,** the Governing Constitution of the Undergraduate
27. Student Government Article IV. Section B. Subsection 2. will be amended to allow an
28. exception for part time college credit plus senators; and

29. **Therefore, let it further be resolved that,** the Undergraduate Student Government
30. recommends the ability for a College Credit Plus senator to attend General Assembly via
31. video chat and that the term be limited to a maximum of one academic year with the seat
32. being appointed whenever it is unfilled.
