A Resolution Formally Supporting Ohio House Bill 310 (Collins Law)

In the Senate of the Undergraduate Student Body here assembled,

- 1. Whereas, the Undergraduate Student Government represents the undergraduate student voice
- 2. at Bowling Green State University; and
- 3. Whereas, Bowling Green State University and the Undergraduate Student Government
- 4. aim to ensure all student voices are represented within the Senate; and
- 5. Whereas, Stone Foltz was a second year undergraduate at Bowling Green State University
- 6. and was only 20 years old when he lost his life due to an alleged hazing incident; and
- 7. Whereas, hazing is completely unacceptable and no student should ever have to experience it
- 8. and the Undergraduate Student Government condemns hazing in all forms and;
- 9. Whereas, Ohio House Bill 3101 (Collins Law) is named after Collin Wiant, an Ohio
- 10. University student who lost his life to hazing in 2018; and
- 11. Whereas, this bill would make hazing a felony in the state of Ohio when drugs or alcohol are
- 12. involved and;
- 13. Whereas, it also requires that guardians of students involved in prohibited incidents be
- 14. notified and (to the extent that the Family Educational Rights and Privacy Act would allow),
- 15. have access to the written reports regarding the prohibited incident; and
- 16. Whereas, currently it has been introduced in the State Senate and was referred to the
- 17. Senate Education Committee and;
- 18. Whereas, this piece of legislation is essential in holding guilty parties accountable to the
- 19. fullest extent in hazing crimes and;
- 20. Whereas, Ohio House Bill 310 ensures that the state of Ohio commits to ending hazing
- 21. across the state; and
