

**Financial Responsibility Agreement**  
**Version: 01-29-2007; valid until 01-26-2008**

**1) My Responsibility to Pay Educational Expenses - Mandatory**

I understand and acknowledge that the educational expenses incurred by me to attend Bowling Green State University ("University") for this semester and future semesters will be charged to my University Bursar account as they become due. I agree that each charge listed for tuition, fees, University-sponsored student health insurance, housing, meal plans, and related matters are considered "educational expenses". Once these charges are added to my Bursar account they will remain as my debts to the University until they are paid. I promise unconditionally to timely pay all such educational expenses in full to BGSU.

**2) My Responsibility to Pay Other Charges to My Account - Mandatory**

I understand and acknowledge that costs and expenses other than "educational expenses" incurred by me at the University may be charged to my Bursar account. These charges could include, but are not be limited to, library late charges, parking fees or fines, late registration fees, repair or replacement costs for damages done to University property, and other University charges not considered "educational expenses". Once these charges are added to my Bursar account they will remain as my debts to the University until they are paid. I promise unconditionally to timely pay all such noneducational expenses in full to BGSU.

**3) Collections - Mandatory**

I understand and acknowledge that the precise amount of my educational expenses and other expenses and costs incurred by me and owed to the University will be available at all times for me to review on-line at MyBGSU found on the University internet Home Page (<http://www.bgsu.edu/>).

I understand and acknowledge that the current net amount of my charges and credits (last bill and transactions since that bill) of my educational expenses and other expenses incurred by me and owed to the University will be available for me to review at web site <https://my.bgsu.edu/>

If I disagree with that amount I realize that it is my responsibility to contact the Office of the Bursar as soon as practicable. I further understand and acknowledge that my failure to timely pay my debts to the University can result in the University filing an unfavorable report with credit bureaus, commencing collection activities (including litigation), refusing to register me for another semester, and/or refusing to release my transcript or diploma. I also understand and agree that in the event that collection activity is commenced by the University, I shall be responsible for all costs of collection incurred by the University and the State of Ohio, including, but not limited to, reasonable attorneys' fees.
