

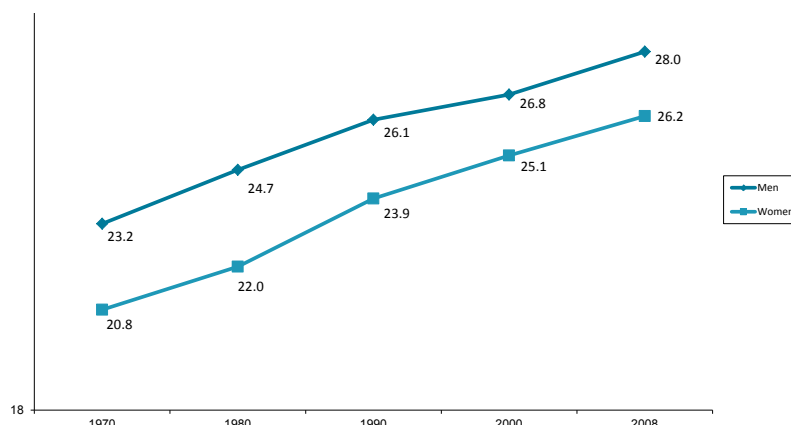
# Median Age at First Marriage in the U.S., 2008

## Link to Most Recent Family Profile

### Change in Median Age at First Marriage, 1970 - 2008

- Median age at first marriage in the U. S. has increased steadily since 1970.
- In 2008, median age at first marriage was 28 years old for men and 26 years old for women. This means that half of men were younger than 28 years old, and half of women were younger than 26 years old when they married for the first time.
- The gender gap in median age at first marriage has remained stable over the past 38 years.

### Median Age at First Marriage Among Racial/Ethnic Groups, 2008

- Median age at first marriage is highest for non-Hispanic Black men (30.1 years) and lowest for Hispanic women (25.4 years).
- The gender gap in median age at first marriage is the smallest among non-Hispanic Blacks (0.3 years) and the largest among Asians (3.1 years).

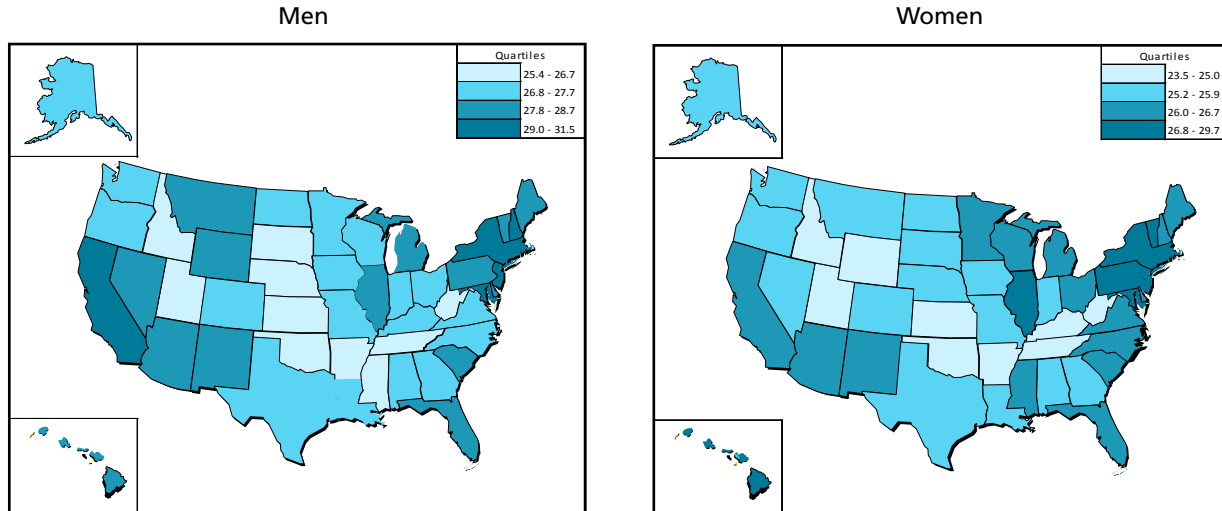

### Median Age at First Marriage by Gender and Geography, 2008

- States with the highest median ages at first marriage are clustered in the Northeast.
- Some Midwest and Mountain West states tend to have the lowest median ages at first marriage.

### Five States with the Highest and Lowest Median Age at First Marriage, 2008

- For both men and women, Washington DC has the highest median age at first marriage (31.5 years and 29.7 years, respectively).
- For men, Idaho has the lowest median age at first marriage (25.4 years), and for women, Utah has the lowest median age at first marriage (23.5 years).
