 - All major penalties - 7 minutes
- Protective hockey equipment required, including helmet and full face mask

- Playoffs:**
- Five minute sudden death
 - 3 man shoot out

Conduct

- Any player ejected from a game will be suspended from playing the next game.
- A second ejection will result in expulsion from the League.
