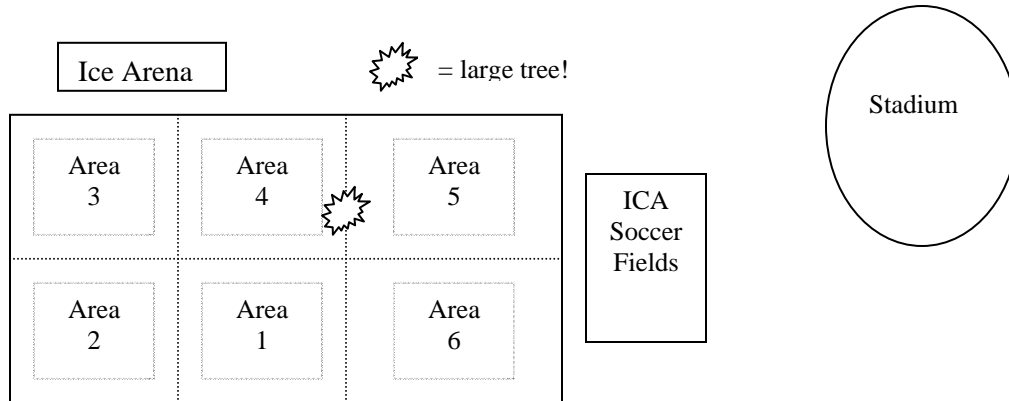


**Recreation and Wellness Outdoor Facilities, 2010-11 School Year  
Area and Descriptions**

Intramural Fields = The **lighted and irrigated IM field area** (just south of the Ice Arena) includes field areas 1-4, and represents a rectangular area encompassing ~8 acres. Utilizing lights also accrues a Rec Sports rental and employee charge. Immediately to the east of that space is another **unlighted area, without irrigation** (field areas 5 & 6) that spans ~ 6 acres. During the academic year, RecWell (RW) schedules these areas, but in the summer, the Intercollegiate Athletics Department (ICA) does the schedules. RecWell and ICA events have priority within these areas, but other users may request the space, as available.



College Park (CP) Tennis Courts & Field = Four (4) outdoor tennis courts located inside a fenced area, with coin operated lights (\$.50/30 minutes). One grass sports field along Poe Rd.

Kreischer/Harshman Basketball Courts = Four (4), lighted 94' x 50' outdoor basketball courts (10' between courts), are located between the Kreischer and Harshman Quads (residence halls). Court lights are activated automatically via an “electronic eye” when evening nears, but if electrical power outlets are needed, 2 weeks advance notification is required for activation.

Student Rec Center (SRC) Sand Volleyball Court = One (1) sand court is located outside the northeast corner of the SRC.

Perry Field House (PFH) Mud Pits = Two (2) mud pits are located just behind the PFH. These are typically used for mud volleyball, tug of war, or other fun, messy activities! For events requiring wet, messy mud, a city water permit must be obtained to hook into the fire hydrant, by calling the Fire Department (352-3106). Also contact BGSU Safety Officer, John Curlis (372-2171). If the ground will need to be tilled up by the Grounds Dept. for your event, 2 weeks advance notification is requested.

“Overtime” = When authorized, events running 30+ minutes past their contracted finish time may be charged up to double the standard rental rates for facilities, equipment, and/or employees.

### General Facility Policies:

- Certain events/facilities may require BGSU security, medical, or supervisory personnel.
- Group may need to provide a copy of their certificate of liability insurance, naming BGSU as a certificate holder in the amount of \$1 million
- All BGSU Student Code policies will be in effect for BGSU groups.
- No glass bottles or containers are permitted.
- No paint on playing surfaces or equip. without permission.
- No vehicles may be driven onto fields or parked along roadways during event.
- No rollerblade activity is allowed on RecWell tennis, basketball, or parking lot surfaces
- Groups supply own athletic and other equipment, unless specified in contract.
- Groups preparing food (hot dogs, hamburgers, etc.) must contact the Environmental Health and Safety Office at 372-2171 and/or the facility scheduler for requirements. Pre-packaged food is allowed.
- Weather guidelines may be utilized to protect participants and facilities.
- Parking policies must be followed, with some parking restrictions possible
