

## **FACULTY MENTOR RECOGNITION**

One of the recommendations from the constituent groups to the President was that we all do more to recognize the good work and dedication of our University faculty, classified and administrative staff.

Therefore, the Senate Executive Committee formed an Ad Hoc Committee consisting of the Provost, three Senate officers, two other Senate members, and one representative each from USG and GSS to formulate additional recognition's for faculty.

Below is one such recognition and its nominating criteria. Faculty are urged to nominate other faculty or themselves for this recognition. We hope that this recognition will bring to positive light the work of our colleagues. Nominations are due in the Faculty Senate Office by **Monday, March 10, 2008** in the Faculty Senate Office. The recognition ceremony will take place at a faculty luncheon **on Tuesday, April 08, 2008** from 11:30-1:30 in the Bowen-Thompson Student Union McMaster Room (Room 308).

### **Purpose**

1. To recognize each year a faculty member for outstanding professional support of his/her colleagues.
2. To focus upon the importance of faculty efforts toward the development of teaching, research and service initiatives among colleagues.

### **The Recognition**

The recognition shall be an engraved plaque and a \$1,000.00 cash award.

### **Criteria**

1. The support being recognized will be a series of continuing quality contributions to one or more faculty colleagues employed by the University.
2. The support provided may consist of: a.) participation in the development of teaching or advising methodologies, b.) assistance with the development of research products such as grants, publications or presentations, and c.) promotion of a colleague's participation in professional organizations or governance at the unit, college or University levels.

### **Eligibility**

Any Bowling Green State University faculty member (with 50% or less administrative duties), excluding members of the selection committee is eligible

### **Procedures**

1. Any BGSU faculty member may make a nomination for this recognition.
2. The nominator should submit a letter of nomination (no more than 500 words); vita of the nominee (maximum of 10 pages), and three (no more than one page each) letters of support.
3. The selection committee for this award will be the Senate officers, a representative from the Office of the Provost, a representative from Graduate Student Senate, and a representative from Undergraduate Student Government.
