"Lessons Learned from the Opiate Epidemic"

November 14 luncheon speaker is Lorrie Lewandowski

Lorrie Lewandowski received a Masters Degree in Social Work from Ohio State University and is currently licensed as an Independent Social Worker, Ohio Certified Prevention Specialist and Chemical Dependency Counselor in the State of Ohio. Over the past 23 years, Lorrie has worked in both clinical and prevention settings with adults, youth, families and communities. She was hired as Associate Director of the Wood County Alcohol Drug Addiction Mental Health Recovery Board in 2013. She became an adjunct professor for Bowling Green State University in the School of Social Work in 2010 and taught Cultural Diversity, Oppression and Social Functioning. On the state level, she was a member of the board of the Alcohol Drug Addiction Prevention Agency Ohio (ADAPAO) for eight years. Her life long interest in the field of prevention and treatment has compelled her to ask the "why" question regarding adult and youth high-risk behaviors and has caused her to become a strong advocate for developing systems that contribute to the wellbeing of those living with mental illness and the disease of addiction.

Lorrie will speak to us about the perfect storm that caused the development of the opiate epidemic, the trajectory of the epidemic over the last 10 years, daily impact in Wood County and Ohio and local problem solving approaches.

Summary of Ohio Council of Higher Education Retirees (OCHER) Board Meeting September 20, 2016

Roger Anderson attended the OCHER Board meeting in at STRS Headquarters in Columbus. President Roger Anderson opened the meeting. He recommended that Richard Hill, OSU, past HPA representative and reporter on Legislative issues and STRS Board meetings, be inducted into the OCHER Hall of Fame. Hill retired from the OCHER Board effective, May, 2016. The motion to approve the recommendation was unanimous. Nancy Wardwell passed out the OCHER Annual Report. The minutes of the May 17, 2016 were approved. The treasurer's report showed a balance of \$5,610.96 in the OCHER account as of September 20.

Michele Hobbs presented the OPERS Report. There are a number of legislative issues that OPERS is monitoring. House Bill 520, sponsored by Reps. Kirk Schuring (R. Canton), and Dan Ramos (D. Lorain), contains a number of suggested minor changes in the pension programs for all five Ohio retirement systems. The first hearing on the bill was held in the House Health and Aging Committee on May 4. The bill is expected to come up during the lame duck session of the state legislature after the November election. OPERS is working with the other pension systems and Rep. Schuring to resolve concerns centered on the Alternative Retirement Plan mitigating rate. House Joint Resolution 6 would have placed a proposal on the November ballot to prohibit state pension systems and state agencies from investing in companies with business operations in countries designated as state sponsors of terrorism. The Ohio Retirement Study the Council has recommended against this resolution as have the pension systems. Gabriel, Roeder, Smith and Company will present to the OPERS Board 50 year actuarial projections of Base Retirement Benefits.

Carl V. Leier, of the Ohio State Retirees Association who is one of OCHER's representatives to the Health Care and Pension Advocates Board was introduced. At the September 6 HPA meeting, the STRS monthly timeline (August, 2016-June, 2017), for pension and health care discussions/recommendations/decisions was presented. The challenges facing the STRS Health Care Program were presented by Greg Nickell and STRS staff. These challenges are: the increasing age of retirees with extended retirement years; reduced investment returns; and the cost of health care.

Marla Bump, Director of Government Relations for STRS was introduced. At the national level there has been no action on the Public Employee Pension Transparency Act (PEPTA), or the Secure Annuities for Employment Retirement Act, both of which STRS opposes. No action is expected until after a new Congress convenes. Bump reported that the STRS Board has hired a consultant to do an Asset Liability Study. The STRS Board will also be doing a five year review. In September the STRS Board started reviewing the STRS Health Care Program. Five faculty members have filed a class action suit (Clark vs. STRS), in a State District Court against STRS, challenging the mitigating rate. The mitigating rate is 4.5% charged to the STRS's employer contribution for contributors who chose an Alternative Plan rather than the STRS pension plan. The case is at the discovery phase. At the state legislative level, STRS has met with Representative Schuring, sponsor of HB 520. He has agreed to maintain the 4.5% mitigating rate which is in the bill. There will be no vote on the bill until the lame duck session of the legislature after the November election. HJR 6 seems to be dead for 2016. The Governor has appointed his representative to the STRS Board.

[Editor's note: HJR 6, if passed by a three-fifths majority of both Houses, would have been placed on the ballot in November, 2016 as a Constitutional Amendment. The amendment would require state agencies and pension funds to end investments in companies with specific business operations in Iran, Sudan, Syria, and Cuba.]

Dr. John Cavanaugh, Executive Director of ORTA, made a few remarks. He said the former director of PERI has formed a new organization supposedly to better represent members of all five pension systems. He has sent letters to OPERS and ORTA members using the logo of the new organization and the logos of OPERS and ORTA seeking membership contributions to his organization. ORTA has sent him a letter requesting that he "cease and desist" sending letters to ORTA members. His organization so far is not officially sanctioned by the state of Ohio. Dr. Cavanaugh pointed out that HPA is an essential organization and needs to be supported.

After lunch the OCHER Board heard from Greg Nickell, Director of Health Care Services for STRS. Nickell reported that the STRS Board devoted two days at their meeting in September to examine Health Care to gain an understanding of options for achieving a sustainable health care program. On Thursday the Board discussed what members valued in STRS's Health Care Plans; why Retirees opt-out of STRS's Health Care Plans; and How are Retiree Health Care Benefits Provided in Other States." On Friday the STRS Board discussed how the STRS Health Care Plans Measure Up; examined Health Care Pathways; evaluated the pros and cons of exchanges; and looked at the Minnesota Health Savings Plan for Active State Employees. With the 2017 changes in the STRS Health Care System, Segal and Associates estimate that the duration of the

September 16, 2016 meeting

Margo Kammeyer, Tri-Chair of ASC, called the meeting to order.



Judy Donald retired from Continuing & Extended Education.

The guest speaker was Aaron Kane, Parking Services. Some of the items he discussed were (1) BGSU is moving to a digital license plate recognition software in Fall 2017 (faculty/staff can register 2 vehicles, but students only one; if you have a rental car, you can register that car just for the time that you have it); (2) departments will have the ability to purchase a one-day permit online without needing a paper printed pass; (3) kiosks

will be changing for pay and display, to pay by license plate which will include an app where you can add more time to your parking account from your phone; and (4) they are working on this for Firelands but nothing has been decided.

In the meeting with HR, tuition compensation for retirees and retiree dependents was discussed. This will be the same as current employees and their dependents. A new policy is being implemented for administrative staff who teach courses and will go into effect in Spring 2017. The university did not issue letters this year to staff telling them of their pay increase and new salary for the next year, but did load the increase into everyone's pay beginning September 1.

Since this was the first meeting of the academic year, there were no committee reports.

The scanning of the archived ASC files is complete; now a decision needs to be made on where to store the documents and how to access them.

Next meeting is October 6, 2016 in 201 BTSU with Sandy Heck, Human Resources, as the guest speaker. □



health care funding is extended four years to 2038, assuming a 7.75% rate of return on STRS investments. The four year increase is projected based on the non-Medicare subsidy reduction and the elimination of the Medicare Part B premium reimbursement.

Nickell said under current assumptions, the pension fund is not projected to be 85% funded until 2042. Nickell said the STRS Board plans major health care program changes in 2019. He presented a chart approximating the incremental costs of waiting beyond that date to sustain the health care fund through 2045. He summarized the actions STRS could take in 2019 to provide a sustainable health care program. Under subsidy, the subsidy multiplier could be reduced for all participants; the subsidy could be increased at a fixed rate rather than the actual trend; and STRS could provide the same subsidy amount regardless of Medicare status. Under eligibility, STRS could eliminate all subsidies for non-Medicare enrollees; and/or increase the years of service required for subsidy. Under Plan Design, STRS could significantly reduce coverage through very high deductibles or out-of-pocket maximums. Under funding, the current plan requires 1.64% of payroll to fully fund in 30 years.

The STRS Board was presented with four pathways examined by staff: the current program with 21 years solvency; 30 years of funding; 50 years of funding; and perpetual solvency. Key takeaways from the STRS meeting are that: current funding levels will deplete the Health Care Fund before employer contributions can be reestablished to it; modifying the health care program to achieve 50 years of solvency increases the likelihood that employer contributions to the health care fund can be reestablished in time to maintain ongoing solvency; changes to subsidy and eligibility are the best options for achieving longer-term solvency. Nickell provided a time-line for STRS Board Discussions and Decisions on Health Care Options and a page summary of key program changes in STRS Health Care Programs for 2017. These program changes will be made available to retirees in mailings or on-line information in October, 2016.

Jim Kweder, Chair of the OCHER Advocacy Committee presented the OCHER Policy Priority Recommendations passed by the Board at the OCHER May meeting. The OCHER Board agreed to add one more advocacy recommendation to our list: to monitor any plan by the Medicare Trustees to make a major increase in the Medicare Part B premium for 2017.

Campus and association reports were given.

There being no further business, a motion was approved to adjourn. The next OCHER Council meeting will be November 15, 2016. □
