Chair's Report:

HR Meeting:

- The monthly meeting with OHR was held February 5th.
- The following questions were asked to Viva McCarver, Chief Human Resource Officer:
 - Question: Does our health plan coverage offer options/ incentives for living a healthy lifestyle?
 - Answer: This is something that OHR is exploring the possibility of. We learned that we are one of few Universities that does not have an official Wellness representative (for the University, not just RecWell for example). In order to explore Wellness initiatives, this position would be recommended as a first step.
 - Question: Can you help us understand the difference between staff that can roll over vacation and those that lose it each January if vacation time is not used?
 - Answer: HR is still looking into this and will advise later.
 - Question: Are there any updates on the JAQ review proposal?
 - Answer: There are no updates at this time but this continues to be a goal of OHR. As a reminder, this would be a very large expenditure.
