#### **Provost Report**

- Update on enrollment status: BGSU now has a Common Application System.
- Upcoming academic calendar year change is progressing as scheduled.
- Ohio Tuition Guarantee
  - BGSU Board of Trustees recommended that the Ohio Tuition Guarantee (OTG) be evaluated as a potential application for BGSU.
  - OTG locks tuition/fees & room/board for 4 years, 8 semesters.
  - Most public universities will move to OTG by Fall 2018.
  - Opt out fees discussed: green, media and legal.
  - Regardless of BGSU's position on OTG, BGSU's priority will continue to be providing high quality education.

## **Textbook Affordability**

- Sara Bushong will present at the November 7<sup>th</sup> Faculty Senate Meeting.
- Chair Border introduced Unizin, and requested an update from Provost Rogers on Unizin and Textbook affordability.

Provost Rogers reported:

- Unizin is a tool that interlinks with Canvas.
- Partnered, it could provide cost savings for BGSU.
- Learning analytics will provide increased opportunity to improve student learning.
- Large publishers are interlinked in Unizin.
- Unizin can provide students with immediate access to online resources.
- Chairs & Directors knowledge of the textbook timeline will allow students to get most cost savings.
- Chair Border referred to HB 49 on Textbook Charge
- Discussion regarding Sec. 3345.011, Chancellor group to propose date, possible Summer 2018

- Provost Rogers recommended that FS contact Julie Matuga for more defined data.

- Provost Rogers reported that the workgroup is holding open forums campus wide.
- Ken Borland noted policy concerns: GPA is tied to NCAA, Scholarships, financial aid, etc.
- USG representative reported constituents consulted viewed +/- as a negative change.
- GSS representative reported that constituents consulted saw +/- as motivating and a more accurate reflection of students work.
- Stephanie Walls reported positive feedback from Firelands.
- If adopted, +/- grading anticipated to take affect by Fall 2018.

- Question 23, change as follows:
  - a. Affordable Care Act (Obamacare)
    - b. Medicare/Medicaid
    - c. Private insurance plan
    - d. Spouse or partner's plan
    - e. BGSU provided
    - f. I do not have health insurance
    - g. not specified
- Question 27, remove duplicate word in "space space"
- Again, Question 27, we suggest these survey response options:
  - ➤ I have an office on campus
  - ➤ I have an office off campus
  - > I share an on campus office
- Editorial: Question 29: What type of computer accommodation does BGSU provide you with for you?
- Move demographic survey questions to end of survey
- Adopt a well know standard for ranges with demographic questions
  - > BGSU employment paperwork
  - ➤ U.S. Census Department
  - > U.S. Bureau of Labor & Statistics

#### SECTION H: OHIO FACULTY COUNCIL DELEGATION IV.H

Membership of the Bowling Green State University delegation to the Ohio Faculty Council shall be comprised of the current Chair of Faculty Senate, ex officio; and one member elected on an annual basis by vote of the Faculty Senate. The Vice-Chair of Faculty Senate will serve two consecutive terms, first as

the alternate and then as Chair.

At least one member of the delegation shall attend each monthly meeting of the Ohio Faculty Council in Columbus during the academic year; all three delegates are encouraged to attend any and all such meetings as their schedules permit.

Election of the non-ex officio delegate will be conducted by the Committee on Committees as part of the regular Senate elections during the spring semester. Candidates for the position of elected delegate must meet the eligibility requirements set forth by the Ohio Faculty Council. The elected delegate may serve one or more additional year(s) through re-election.
