COMMUNICATIONS

Dr. Rodney Rogers, President

- Welcome back to Spring 2020. At the end of fall semester, we hosted a series of open forums across campus. Thank you to all who participated in the discussions about the strategic plan. We appreciate your advice and in particular will address the comment that we need to do a better job of communicating updates. There are six overall objectives and three imperatives: 1. Redefining student success; 2. Increasing and connecting research/creative activity to public good; and 3. Empowering and supporting our people to achieve excellence. You will hear more about these imperatives today in Provost Whiteheads report. The Provost and I will be inviting all full time faculty to the University House over the course of spring semester to engage in conversations about how we move the strategic plan and university forward.
- BGSU's first day enrollment for spring semester is up in both student head count and student credit hours. This is very good news in light of the decreasing demographics and that many other institutions in Ohio are experiencing enrollment decreases. Our numbers for Fall 2020 are up in applications and admits.
- Presidents Day on Monday, February 17th is an important time for prospective students and families to visit campus. Student reservations are up 200 this year. The positive experience and interaction with faculty and staff is so critical to students selecting BGSU. Thank you to all for your participation in this important event.
- The last few years we have had some amazing speakers on our campus. Jennifer McCary will be telling you about some upcoming amazing speakers as part of the Beyond the Dream series.

• Life design is a framework utilizing design thinking and we will utilize life design in the redefinition of student success. The goal is to enhance persistence, retention, and four-year graduation rates while developing "life ready" graduates. Another aspect of redefining student success at BGSU is integrating academic and career advising. Ten pilot projects were launched in fall 2019 that included linked and bridge programs to introduce BGSU students to Life Design. The basis for the pilot projects was the the book entitled "Design Your Life". In addition to the 10 pilot projects, 60 BGSU faculty, staff, and administrators participated in a Design Your Life workshop delivered at BGSU, 1/14-16/2020 by personnel from Stanford's d school to include one of the authors of Design Your Life.

Other institutions have utilized life design on a limited basis, however, to goal at BGSU is impact each student. Implementation of early phases of Life Design at BGSU will entail redesigning BGSU 1910, altering SOAR, and innovating Fall Welcome and Opening Week. A steering group with representatives from faculty, staff and the student body will guide Life Design implementation and solicit input from campus.

- Persistence rate 2019-2020 90.71%, 2018-2019 90.53%, 2017-2018 90.79%. Persistence and retentions rates have plateaued over the past three years; therefore we must change our approach to student success.
- In addition to Life design, Dean Craig is leading a group that will ultimately develop BGSU's quality initiative that is required by HLC.
