1 // Outsourcing Resolution- Motion to approve and move to Senate floor, Matt Lavery, Second, Megan Rancier.

Discussion- Concern that the casual reader will think this is specific to the College of Business and not a statement across the board. If we strike item 13 that will make it less ambiguous. Item 10 may have brought it back around to the academic coach model and not specific to the College of Business. The IC does not teach the course, faculty at BGSU are teaching the course. The IC will only assist if the course reach a certain number. Number 8 with involving committee in hiring, we don't go through a search committee for adjunct faculty, they are hired by the Chair. We need to clarify this with the College. There is a question of what constitutes academic instruction. We have two resolutions rolled into one. There is a response to the College of Business and then there is a broad general policy.

Policy tabled 2 // ACADEMIC EXCELLENCE STATEMENT DISCUSSION/RESOLUTION- BGSU will fair better in a post COVID-19 world because of our commitment to academic excellence. Motion to approve resolution, Alex Chaiarelott, Second Ken Borland. Confused what specifically we would want them to follow, some classes have been here since the 1960's. If the classes are out of date. Firelands are different sometimes do not reflect course enrollment on the blue sheets. Going through this process may not solve the problem. Mainly 17& 18 that there is an issue with? Sometimes we get assigned to rooms that we do not choose and it might not meet the requirements from the blue sheet. We would want to see a report from the Classroom Enrollment Capacity committee before finalizing this resolution. We could eliminate 14, 15, and 16 a reiterate student instructor ratios based on pedagogy. In terms of quality, maintaining these smaller class sizes is key to this. There is a problem with room size which is out of our

control. Doesn't have to be phrased in the format of a resolution, but create a statement.
