

A Resolution to Recommend a ROTC Student Clause in all Bowling Green State University Syllabi

In the Senate of the Undergraduate Student Body here assembled,

1. **Whereas**, the Undergraduate Student Government represents the undergraduate student voice
2. at Bowling Green State University; and

3. **Whereas**, Bowling Green State University and the Undergraduate Student Government
4. aim to ensure all student voices are represented within the Senate; and

5. **Whereas**, Bowling Green State University is home to hundreds of student veterans, military
6. students And ROTC students.

7. **Whereas**, Reserve Officer Training Corps is a program in which college students participate
8. in to amplify their career choice in the Armed Forces and;

9. **Whereas**, these students are undergoing training to become leaders within this field and show
10. their dedication and commitment to our country and;

11. **Whereas**, the ROTC program provides students with the tools, training, and experiences to
12. do just that in their futures and;

13. **Whereas**, BGSU is committed to the success of all students, no matter their course of study
14. or future plans and;

15. **Whereas**, there is no mention of ROTC students in syllabi clauses on campus, even though
16. these students account for a large population on BGSU's campus and;

17. **Therefore let it be resolved that**, a clause should be instated in all BGSU syllabi making
18. faculty members aware of the needs of ROTC students and;

19. **Therefore let it be further resolved that**, this clause should state that ROTC students will
20. be required to attend certain events related to their duties as a member of the ROTC program
21. and;

21. **Therefore let it further be resolved that**, professors and other faculty members should not
22. be able to discredit students based on their participation in the ROTC program or for
23. attending mandatory events and;

24. **Therefore let it further be resolved that**, a new clause should be instated into all BGSU
25. syllabi that states the following: “Bowling Green State University recognizes the Air Force
26. and Army ROTC Students dedication to their education and their country. As part of their
27. education, these students may be required to miss class due to mandatory events within their
28. respective program. In the event that ROTC students may need to miss class, contact with the
29. instructor is imperative. However, students may not be discredited due to their status as an
30. ROTC Student. The ROTC programs are housed within Memorial Hall and more information
31. can be found at bgsu.edu.”


