Robert Glidden convocation speaker *Former BGSU dean returns for 10th annual event*

Dr. Robert Glidden, who retired June 30 as president of Ohio University — and is a former dean of BGSU's College of Musical Arts — will be the speaker at the 10th anniversary convocation of the BGSU Retirees Association. The event will be Wednesday, Sept. 15, in 202B Bowen-Thompson Student Union (Community Room). Socializing begins at 11:30 a.m. Reservations are due Friday, Sept. 10.

Dr. Glidden left Bowling Green to become professor and dean of the School of Music at Florida State University in 1979 and then provost and vice president until he was chosen Ohio University president in 1994.

Before joining the BGSU administration, Dr. Glidden served three years as executive director of the National Association of Schools of Music and National Association of Schools of Art.

He has served on the Governor's Science and Technology Council in Ohio and has also chaired the Ohio

'Wanda the Wanderer' tells of her travels since retirement

THIS time we are going to talk about Wanda Montgomery, another big traveler in our organization, as we did last time with Park Leathers and will probably do again next time (but we're not telling who). Wanda now lives in Howey-in-the-Hills, Fla., about 30 miles northwest of Orlando just off the Florida Turnpike.

You will remember Wanda from her position on the BGSU faculty in what was formerly called the Home Economics Department. She came to us well-trained, having earned her BS in home economics education at Ohio State in 1945, her MS in textiles and clothing at OSU in 1954 and her PhD in education at the University of Minnesota in 1973. Her teaching experience was already extensive, including stints as vocational education supervisor for the Ohio Department of Education, Columbus, and at Baldwin Wallace College, Berea.

She also was on the faculty at Marshall University, Huntington, West Va., and for more than three years was the director of the American Home Economics Association project "Global Connections."

Wanda also has had extensive international experience: as a Fulbright Grant teacher in Rangoon, Burma; as a Peace Corps volunteer in Thailand; as a teacher in Songkhla and Bangkok Technical Institutes; as a Community Development officer in the Ministry

of Economic Development Women's Program for the United Nations Food and Agriculture Organization (FAO); as a field officer in Nigeria West Africa; as a United Nations FAO consultant in Botswana, Lesotho, Swaziland, Malawi and the Sudan. She was lecturer at the University of Malawi (Bunda) College of Agriculture, a position filled by the Institute of International Education. She has been or is a member of several professional honoraries and professional organizations including the Ohio and American Vocational Associations; the American, Ohio and Florida Associations of Family and Consumer Sciences (formerly HEA); as well as the International Federation for Home Economics (IFHE); and a number of community organizations such as the Mission and Evangelism Committee of the Presbyterian Community Church; the Howey Garden and Civic Club (having served on its executive board for five years); and of the

Howey Memorial Library as a board member and as a volunteer.

This world-traveler tells me that since retirement she has been in 16 countries for conferences, teaching, consulting, etc. (all as a volunteer) and four or five more just to sightsee. The journeys, which started in 1985, the first year of her retirement, continued through the spring of 2003. They differed in length from three days to five months. Between these travels she has visited 18 states for professional and personal activities.

I think you would be interested in a tally of these trips and activities, and so

At 10th convocation: Free parking behind Union upon request

I have jotted down here the crucial ones.

In 1985 in Tanzania, Wanda conducted a workshop on population education for the American Home Economics Association for Tanzanian teachers; in England she visited a BGSU student teacher in West Sussex; in Thailand she was consultant to Rajadameran University and affiliated colleges.

In 1987 she went to Costa Rica with an exchange graduate program for students from Eastern Carolina University. Then in 1988 she returned to Thailand as a consultant for an FAO Workshop for home economists.

In 1990 she was a consultant to the faculty of the Home Economics Technical Institute, at the Chiang Mai University and Open University.

In 2002 she attended meetings with THEA officers, Chiang Mai University, (Thailand) faculty and IHES (International Home Economics Services).

Wanda's expertise took her also to the Caribbean. In 1989 she traveled to St. Lucia as consultant and teacher at Sir Arthur Lewis Community College (a branch of University of the West Indies); and also conducted a workshop for home economics teachers from sev-

en Caribbean countries. In 1991 she served as consultant and survey team member on out-of-school teen-age girls. In 1995 she was IHES delegate to the Caribbean Association for Home Economics. (CAHE).

These countries were visited for two or more days while en route to assignments, often spending much time with local professional colleagues: Hong Kong, Ivory Coast, Switzerland, Denmark, Hungary and Czechoslovakia. Tours were also made to Martinique, Montserrat, Dominica, and China.

In connection with the Global Connections Project, Dr. Montgomery conducted workshops in Iowa, Louisiana and Indiana for teachers, teacher educators and state education department personnel. Regional and national conferences held in Seattle, Rhode Island, New York City, Minnesota, Maryland, Washington, D.C., Illinois, California and Texas were attended. Visits were also made to New Mexico, Arizona, Missouri, Maine and Virginia.

Wanda plans a trip right now to Kyoto, Japan, for a meeting. Her friend tells her that the cycle she was born in (the sign of the Ox in the Chinese cycle) is responsible for her doing so much traveling. Well, something certainly is!

The Stang Report

STRS BOARD

The Governor signed the pension reform bill, which is effective Sept. 15. It increases the board to 11 and deals with accountability, ethics and oversight. It removes the attorney general and auditor and adds two investment experts, one appointed by the governor and one jointly by the House speaker and Senate president. "Buy Ohio" is a goal but mandated percentages of investments are not required.

The Governor has 90 days from Sept. 16 to appoint the second retiree to the STRS Board. ORTA has submitted three names to fill this interim position. Two retirees will be elected in the spring. Joe Endry, currently retiree representative, does not wish to continue. ORTA has submitted the names of Dr. Lou Diorio, OCHER past president; Neil Johnson Cleveland area, and Dave Speece, Clark County, who has been a member of the ORTA board.

The STRS Board interviewed five candidates for the position vacated by Jack Chapman June 19 and selected Constance Ramser, special learning needs teacher with the Jackson Local Schools, Massillon.

HEALTH CARE

The STRS Board reduced premiums for older members along with drug co-pays and drug out-of-pocket costs. Retirees who have Medicare will pay from \$12 to \$36 less in 2005 for Aetna or Medical Mutual Plus Plan coverage and that individual's spouse with Medicare will save \$36 in annual premiums.

Most non-Medicare retirees will experience only a slight increase in premiums. Non-Medicare spouses will experience an increase of \$59 per month in their premiums if they are enrolled in the Medical Mutual Plus Plan and an increase of \$71 under Aetna Plus Plan. Retail co-payments for a 30-day supply of generic drugs will stay at \$15 per prescription, brand-name drug prescriptions will drop to \$25 and retail co-pay for Tier III drugs will be reduced to \$50.

Mail service co-pay for select brand-name drugs will drop to \$50 for a 90-day supply and Tier III co-pay will drop to \$100. Generic drug co-pays for 90-day mail service will remain at \$30. Maximum out-of-pocket costs will drop to \$1,500. There also are changes in the Catastrophic Plans. These include lowering premiums for all categories of enrollees, including spouses; reducing the medical deductible; and raising the maximum annual drug benefit. Revising the advantages of this program after changes may be prudent for some retirees.

In late October, all current enrollees in the STRS Ohio Health Care Program will receive personalized information for 2005.

ORTA

OCHER became affiliated with ORTA last spring and BGSURA is considered a local chapter. Retired and active teachers are eligible for membership. ORTA monitors the retirement system and pension benefits and acts as a representative of members at STRS and the Ohio General Assembly as well as at the national level. In addition to this type of representation, membership in ORTA provides such member benefits as low long-distance phone rates, affordable long-term care insurance, free hearing tests and low-cost hearing devices, free legal advice by phone and by mail, travel services, auto insurance, vision discounts. First priority for ORTA is stabilizing health care costs. Up-to-date information is available through a newsletter and magazine. Membership fees are nominal but the additional weight of a unified organization is important in efforts to protect and improve the welfare of retired teachers.

OPERS

The reform bill increased the size of the OPERS board to 11 with a second retiree. The governor, and jointly with the House Speaker and Senate President, will appoint investment experts, as is the case for STRS. OPERS also will have an investment expert who is not a public employee designated by the treasurer. Other members will include the director of Administrative Services, and a member from each of these groups: state employees, county employees, municipal employees, and one miscellaneous employee member.

The 2003 return on investments for OPERS was above the benchmark (25.3 percent), the highest achieved since 1985. Preliminary results for fiscal year 2003-2004 for STRS show a return on total investments to be 17.16 percent.

Although OPERS has a better financial base than STRS, its retirees are beginning to feel the pinch of rising health care costs. Indications suggest there will be changes in 2007. Retirees with fewer years of service would pay substantially more for insurance. In general, current and near retirees would feel the least of the benefit pinch. Coverage for spouses of retirees would cost more for everyone, although the increase would be phased in over five years. Contributions by state and local governments will be increased and employees will contribute 1.5 percent more of their salaries, up from 8.5 percent.


AS I WRITE this, Bowling Green State University is preparing for the start of the fall semester, and the National Tractor Pull is beginning its weekend roar.


