CAPSTONE PROJECT: The capstone project (MUS 4500) is required for the degree. Refer to the capstone handbook for details. Student selects two faculty from different disciplines to advise work on a research or creative project that reflects the multidisciplinary nature of the Bachelor of Musical Arts degree. At least one of the two faculty members must be from the College of Musical Arts. Prerequisite: senior class standing and consent of the Assistant Dean.

SPECIAL SCHEDULING CONSIDERATIONS: A number of courses required for the degree are only offered once a year or every other year and must be carefully scheduled by students in consultation with the advisor.
