# **National Crime Victimization Survey, 2010**

# 1 Sample Description

The National Crime Victimization Survey (NCVS), formerly National Crime Survey (NCS), is a nationally representative survey that collects data on both personal and household victimization. Its primary focus is to develop information concerning victims and the consequences of crime, estimate crime not reported to the police, provide uniform measures of selected types of crime, and allow for comparisons over time and types of areas. Information on both personal and property crime are collected. Screening questions are asked prior to the interview to screen for victimization within the last six-months, and the household respondent is also asked questions concerning crime against the household as a whole. Collected since 1973, the NCVS asks questions pertaining to type of crime, time, month, location, relationship to offender, property lost, if the crime was reported to the police, reasons for not reporting the crime, and offender use of weapons, drugs, and alcohol. Basic demographic characteristics are also collected. (Summary provided—in part—by the United States Department of Justice via ICPSR).
