1 Description

The United States Census is NOT a sample, but a count of every resident in the United States. Mandated by the U.S. Constitution, the data collected by the decennial census are used to determine the number of seats each state has in the U.S. House of Representatives. The information is also used to distribute billions of dollars in federal funds to local communities. The first census--conducted in 1790--included questions on gender, race, relationship to the household head, name of the household head, and where applicable, the number of slaves. Due to the implementation of the American Community Survey (ACS), which replaced the Census long-form, the most recent census--conducted in 2010-was one of the shortest in history. Seven questions were asked of everyone in the household; name, gender, race, ethnicity, and whether they sometimes lived somewhere else. Additionally, the household head was asked how many people lived in the residence and what type of residence it was (e.g., house, apartment).
