

Measurement of Marriage, Divorce, Remarriage, & Cohabitation

- Provide marriage and divorce data at the national, state, and local levels.
- Standardize marital status information across surveys.
- Collect summary measures of marriage and cohabitation history.
- Collect full marital and cohabitation histories.
- Include special populations.
- Share existing questionnaires and knowledge.
- Improve tabulations and publications of marriage and family formation data



Measuring the Causes and Consequences of Marriage, Divorce, Remarriage, & Cohabitation

- Increase the detail of household relationship information
- Develop and test key concepts
- Include measures of family-related values and attitudes
- Obtain information for all fathers and mothers in studies of children
- Develop standard sets of variables to track indicators of the causes and consequences of family change
- Develop a plan for a new family study to examine the causes and consequences of family change
- Field a couples study

Recommendations

- Census include better and more inclusive data on marriage and cohabitation.
- Identify all biological parents and any social parents in the household.
- Obtain marital and cohabitation histories for adults.
- Improved family formation data, especially from minority men. Parallel data from mothers and fathers.
- Defining relationship quality and ensure asked in meaningful way across populations.
