If a student would like to waive a course being offered during his or her first semester at BGSU, the student should submit a proposal for course/practicum waiver and all supporting materials within the 1<sup>st</sup> two weeks of the first semester of entering the program. A student should attend all classes until notification of an approved course waiver. If the student would like to waive a course(s) offered in any semester other than the student's first semester, she/he should submit a proposal by November 1<sup>st</sup> of the year she/he enters the program. The evaluation review committee will meet once during the fall semester to review student materials and instructor recommendations and render a decision. The decision of the evaluation review committee is reviewed by the Director of Clinical Training and communicated to the student.
