- 2020-2021 *The Coronavirus Pandemic: Predictors and Consequences of Compliance with Social Distancing Recommendations.* Peggy C. Giordano (principal investigator); Monica A. Longmore and Wendy D. Manning (co-investigators). National Science Foundation. \$200,000 (d=\$140,845) Period 5/01/2020 to 4/30/2021.
- 2020-2022 *Mechanisms Underlying Desistance from Crime.* Peggy C. Giordano (principal investigator); Monica A. Longmore and Wendy D. Manning (co-investigators). National Institute of Justice. \$797,079 (d=\$565,791) Period 1/01/2020 to 12/31/2022. This three-year mixed method project on desistance will provide new insights about the relative salience of individual-level and social mechanisms driving change, and greater specificity about the underpinnings of each of these pathways. The project will include analyses of six waves of existing data, in-depth interviews with respondents representing varied persistence and desistance patterns based on self-report and official records (n=50), and interviews with a romantic partner (n=25) and parent (n=25). Each will provide their unique perspectives on what fosters or inhibits desistance processes. A new desistance survey module targeting respondents who engaged in early delinquent/criminal behavior (n=578) will focus on challenges and derailments as well as successful desistance, and will allow us to document gendered patterns.

National Institute of Justice (\$500,000). The proposed research builds on a ten year mixed method longitudinal study (The Toledo Adolescent Relationships Study). New structured surveys (respondents will average 31 years of age), combined with the large body of previously collected data will provide a comprehensive basis for assessing the relative salience of specific hypothesized pathways. We address the following objectives: (1) Examine the effect of parental incarceration on a full range

of child well-being outcomes for all children born to the TARS study participants (n=approximately 1400). (2) Expand the lens beyond the focal parent to determine whether variability in crime and incarceration exposure across the child's full network (including multigenerational patterns of incarceration) explains additional variance in child well-being outcomes. (3) Examine incarceration-specific hypotheses to identify mediating mechanisms, including consequences of incarceration for changes in economic circumstances, social relationships, and perceived stress/stigma.

Specifically, we seek to document patterns of persistence and 'desistance' of these behaviors, investigate the underlying mechanisms associated with the process of making and sustaining positive changes, and identify social and individual factors that distinguish desisters and those who continue this negative pattern within their relationships.
