Purpose

1. To recognize each year a faculty member for outstanding contributions to the community or to other local, state, national, or international communities.
2. To recognize the importance of faculty service and the contribution of community involvement to the education and image of Bowling Green State University.

The Recognition

The recognition shall be an engraved plaque and a \$1,000.00 cash award.

Criteria

1. A demonstrated record of involvement in a community.
2. Service that enhances the relationship between the University and the community served.
3. Demonstrated ability to infuse community involvement and/or public service into the classroom in a way that enhances the education of BGSU students at the graduate or undergraduate level.

Eligibility

Any Bowling Green State University faculty member, excluding members of the selection committee is eligible.

Procedures

1. Any BGSU faculty member may make a nomination for this recognition.
2. The nominator should submit a signed nomination form, letter of nomination (up to 500 words); vita for the nominee (maximum of 10 pages), and two (no more than one page each) letters of support.

DISTINGUISHED SERVICE AWARD

Anne Gordon, 2018 Recipient

Purpose

1. To recognize each year a faculty member for outstanding continuous University service.
2. To focus upon the importance of faculty service and the requirement of dedicated faculty for the development and enhancement of Bowling Green State University.

The Recognition

The award shall be an engraved plaque, cash award of \$1,000.00 and a parking space.

Criteria

- The service being recognized will be a series of continuing quality contributions to the University.
1. The service may consist of continuous quality participation in the faculty governance process at any or all levels, significant contributions to the learning environment, and/or to the quality of internal/external university relations, or participation in any other service that significantly advances the mission of Bowling Green State University.

Eligibility

Any Bowling Green State University faculty member, excluding current officers of the Faculty Senate.

Procedures

1. Any faculty member may make a nomination for the award.
2. The nomination should be accompanied by a signed nomination form, letter of recommendation and appropriate documentation (Vita).

FACULTY MENTOR RECOGNITION

Lee Nickoson, 2018 Recipient

Purpose

1. To recognize each year a faculty member for outstanding professional support of his/her colleagues.
2. To focus upon the importance of faculty efforts toward the development of teaching, research and service initiatives among colleagues.

The Recognition

The recognition shall be an engraved plaque and a \$1,000.00 cash award.

Criteria

1. The support being recognized will be a series of continuing quality contributions to one or more faculty colleagues employed by the University.
2. The support provided may consist of:
 - a. Participation in the development of teaching or advising methodologies
 - b. Assistance with the development of research products such as grants, publications or presentations
 - c. Promotion of a colleague's participation in professional organizations or governance at the unit, college or University levels.

Eligibility

Any Bowling Green State University faculty member, excluding members of the selection committee is eligible.

Procedures

1. Any BGSU faculty member may make a nomination for this recognition.
2. The nominator should submit a signed nomination form, letter of nomination (no more than 500 words); vita for the nominee (maximum of 10 pages), and one (no more than one page) letter of support.

LEADERSHIP AS A CHAIR/ SCHOOL DIRECTOR

John Laird, 2018 Recipient

Purpose

To recognize a department chair or school director whose leadership has contributed significantly to the University.

The Recognition

The recognition shall be an engraved plaque and a \$1,000.00 cash award.

Criteria

A demonstrated record of any or all of the following:

1. Curricular innovation or new programs
2. Maintenance and enhancement of a department's or school's mission
3. Faculty development
4. Community Outreach
5. Student-Faculty Relations
6. Contributions to the campus community
7. Promotion of the University's core values

Eligibility

Any department chair or school director serving at the time of the nomination, excluding members of the selection committee is eligible.

Procedures

1. Any BGSU faculty member may make a nomination for this recognition.
2. The nominator should submit a signed nomination form, a letter of nomination (no more than 500 words); vita for the nominee (maximum of 10 pages), and one (no more than one page) letter of support.

LIFETIME ACHIEVEMENT RECOGNITION

No Nomination, 2018

Purpose

1. To recognize a senior faculty member and/or administrator with faculty rank for outstanding contributions to BGSU over a period of twenty (20) years or more.

2. To focus upon an individual who's teaching, scholarly work, service, and administrative skills have contributed significantly to the vitality of the BGSU community.

The Recognition

The recognition shall be an engraved plaque and a \$1,000.00 cash award.

Criteria

1. The individual should be widely acknowledged across campus for exceptional teaching, scholarly/creative work, service, and/or administrative skills insofar as these activities have made BGSU a more vital educational community for students, staff, faculty, and administrators.
2. The individual should have had at least 20 consecutive years as a faculty member and/or administrator with faculty rank at BGSU and have demonstrated significant contributions to the BGSU community for a sustained period of time.

Eligibility – TTF Award

Any full time, tenure track faculty member or administrator with faculty rank with at least 20 years of service at BGSU.

Eligibility – NTTF Award

Any full time or part-time non tenure track faculty member or administrator with faculty rank with at least 20 years of service at BGSU.

Procedures

1. Any BGSU faculty member may make a nomination for this recognition.
2. The nominator should submit a signed nomination form, a letter of nomination (no more than 500 words); vita for the nominee (maximum of 10 pages), and one (no more than one page) letter of support.

UNIT RECOGNITION

Dept. of Psychology, 2018 Recipient

Purpose

1. To recognize each year an academic or instructional service unit that makes an outstanding contribution to Bowling Green State University.

2. To focus on the importance of faculty who work together to make a difference in the educational environment at BGSU.

The Recognition

The recognition shall be an engraved plaque and a \$1,000.00 cash award.

Criteria

1. A demonstrated record of effective and sustained collegiality
2. A demonstrated commitment to the University's Core Values
3. Recognized impact upon the quality of the educational program

Eligibility

Any group named above.

Procedures

1. Any BGSU faculty member may make a nomination for this recognition.
2. The nominator should submit a signed nomination form, a letter of nomination and appropriate documentation.
