<u>EAB presentation:</u> Committee members were made aware everyone has access to the EAB library with BGSU username. Chair, Hippler thanked all for doing something different for first faculty senate meeting and asked for feedback. General feelings were it was greatly appreciated. Feedback from committee members:

- Suggested to refer to it as "Kick Off for the Year" if holding again next year.
- Send out information sooner for better attendance.
- Advertise separation from meeting/speaker. Three-hour time block is challenging for most faculty.

- Suggested to add Sponsored by Faculty Senate.
- Live stream to Firelands.

## Discussion of topics for future Senate meetings:

- Topic of quality of instruction (face to face) and online teaching and learning.
- Reclaiming our Value handout with Matt Pellish's ideas. Could rank which items are most important.
  - General topics what would we be interested in at BGSU. ACTION Table for SEC meeting.
- Senate take on a more deliberate topic/meaningful topics at Senate meetings to help set the agendas.

<u>Provost's Imperatives and Goals</u>: Feedback on how do we work together for teaching and learning was asked. Discussions ensued.

- Discussion of action items of the following were deliberated:
  - o Big push on differential and evolving the BGSU experience.
  - Falcon flight plan push from Board and State of Ohio.
  - Move toward an Undergraduate plan.
  - Research and evolve our research.

## For SEC:

- Request for 1-2 Senators to serve on Faculty180 committees: Bill Balzer is asking
  for Senate members to serve on an ad hoc committee for the purpose of policy
  and procedures regarding software that faculty will enter all of their repository
  for vita/supporting documents etc. Faculty online reviews are currently inputted
  through Cincinnati Group, Faculty 180 possible replacement. MOTION (Robyn
  Miller) to self-nominate Robyn Miller to serve on Faculty180 committee.
  (Second: Jane Wheeler). Passed unanimously.
- Com/Com: Appointments are needed for several open spots for Committee on Professional Affairs (CPA). SEC will need to appoint two faculty members. In addition Com/Com will appoint two Senators to CPA. Com/Com Chair, Christopher Rump will make an announcement for four members to the CPA via email.
- A& B
  - o Referral to A&B, clarification of OFC member duties (i.e. "alternate")

- Referral to A&B, clarification of who the adjunct senators are representing (i.e. not Colleges but all adjuncts) with respect to the Article 14 Charter interpretation from last year.
- CAA
  - Referral to CAA of allowing Deans more discretion in the second-strike sanction in the Academic Honesty Policy
