If you are unable to appear in-person, you may complete this document in the presence of a notary. See the back of this form for notary instructions.

Instructions:

1. The student must appear in person at Bowling Green State University to verify their identity by presenting an unexpired valid government-issued photo identification (ID), such as but not limited to, a driver’s license, other state-issued ID, or passport.
2. The institution will maintain a copy of the student’s photo ID that is annotated by the institution with the date it was received and reviewed, and the name of the official at the institution authorized to receive and review the student’s ID.
3. The student must sign in the presence of the institutional official the Statement of Education Purpose provided below.
