If you are certifying that you are a U.S. citizen, SFA will process your documentation, and federal aid can disburse on the normal disbursement cycle for the session/semester.

If you are certifying that you are an eligible non-citizen, SFA must initiate an online confirmation process to the U.S. Citizenship and Immigration Services. USCIS will send BGSU SFA a written response confirming or denying the validity of your documents. Federal aid cannot be disbursed until the USCIS confirmation response is received.

If in reviewing your documents, there is reason to question the validity of the documents submitted, SFA may request additional documentation. If SFA has conflicting information about a student's immigration or citizenship status or has any reason to believe information on the FAFSA is incorrect, SFA must resolve such discrepancies before disbursing federal financial aid.
