 - Senator Vigue stated that she though the legislation was good, but thought that American students should be referred to as domestic students and recommended that we use "and" in some places
 - Legislation Passes (35 in favor, 0 against, 3 abstentions)

New Business

- Funding for professional development discussion
 - A discussion was lead by the Senator from the Sociology Graduate Student Association regarding getting funding for professional development based on the type of professional development experience (Presenting, Leadership, Attending). Give an increased amount for those who are presenting at conferences rather than those who just attend.
 - Vice President Landis recommended that if this is something we want to do, then individuals
 interested in working on this topic should collaborate with an executive member and draft
 legislation.
 - A small committee will be contacted to identify a method that would work. That committee will receive information regarding the breakdown of types of participation in FPD and the distance travel. We'd be very interested in what a group of you would have to say.
- Graduate Certificate Program in Online Education
 - Gives background and qualifications to participate in online opportunities.
 - The General Assembly agreed to investigate this topic further.
- Obtaining a teaching license
 - Report on the feasibility of this topic.
 - What can you do to obtain a teaching license after your master's degree? You must take a 4-year education program in order to do that. There are a few classes that will be actually transferred. The alternative route involves you finding a high-school to sponsor you and could possibly take a few catch-up classes in order to teach sooner. This is more realistic for more specialized programs.
 - Q: (Senator, Music) Will this damage the reputation of BG's teaching program? A: No, I do not believe that it will
 - There issues with converting undergrad courses for graduate credit. The state of Ohio will actually have a certificate program. In that sense I will presume the issue will be taken care of at state level. This can take up to 3 to 4 years to obtain in terms of paper work.

Bowling Green State University Graduate Student Senate Resolution 2009.F4

Resolution Opposing a Shuttle and Transportation Fee Indiscriminate of Student Use, and Supporting Investigation of Alternate Means of Levying a Shuttle and Transportation Fee

WHEREAS, the Graduate Student Senate recognizes the utility of the shuttle service, the effort of its dedicated employees, and the benefits in both convenience and safety of the shuttle service to the student population, and endorses sustaining the shuttle service, and

WHEREAS, the graduate student body recognizes that parking services can no longer finance the shuttle service through parking passes and citations alone, and that an added student fee has therefore been proposed to maintain the shuttle service, and

WHEREAS, the Graduate Student Senate supports the Undergraduate Student Government in their request for an expansion of the shuttle service to include all resident parking lots and a late night downtown route, and

WHEREAS, the Graduate Student Senate recognizes that a majority of the Graduate Student body may not regularly utilize the shuttle service, and

WHEREAS the Graduate Student Senate believes that Shuttle and Transportation Fee should only be applied to Graduate or Undergraduate students who choose to utilize the shuttle service, and

WHEREAS the Graduate Student Senate believes that a Shuttle and Transportation Fee should not be applied to those Graduate or Undergraduate students who do not choose to utilize the shuttle service, and

WHEREAS representatives from GSS have discussed alternate means of levying the proposed fee in a manner consistent with the above stated beliefs, and

WHEREAS, the Graduate Student Senate eagerly awaits the opportunity to continue working with Chief Wiegand, Parking Services, and the Office of Vice President Stoll on the proposed Shuttle and Transportation fee; each of whom GSS commends for their consideration of the welfare of the Bowling Green State University student body as a whole,

LET IT BE THEREFORE RESOLVED that the Graduate Student Senate does not support a Shuttle and Transportation fee levied indiscriminately as to individual student use of the Shuttle Service, and

ALSO, LET IT BE THEREFORE RESOLVED, the Graduate Student Senate supports the investigation of alternate means for levying the proposed Shuttle and Transportation Fee that would take individual student utility of the Shuttle service into consideration.

WHEREAS, Article II Section 3.B of the GSS Constitution bylaws states that the Academic and Professional Development Programming Chair will serve as a lead in the planning and implementation of all aspects of the GSS and Shanklin Awards program (held in April), and

WHEREAS, the 2009-2010 GSS President and Academic and Professional Development Programming Chair are working to create a Colloquium to further encourage and promote graduate student research in all disciplines, and

Bowling Green State University Graduate Student Senate Legislation B2009-2010.F2

GSS Bylaws Amendment: Funding for Professional Development

WHEREAS, the Graduate Student Senate awards professional development funds for graduate students attending professional development events, and

WHEREAS, according Article III Section 4(b.3) currently states that "[f]unding will be distributed equally among all approved applications except when requested amount is less than award. In such case, the award will equal the request.", and

WHEREAS, Graduate Student Senate would like to acknowledge the additional effort and workload of those graduate students presenting or accepting leadership roles in professional organizations, and

WHEREAS, Graduate Student Senate would like to encourage these efforts by awarding an additional 15% more for professional development funding to those graduate students who commit to the greater effort and workload involved in presenting research or accepting a leadership role, and

WHEREAS, Graduate Student Senate would still award funding for those graduate student attending or otherwise participating in professional development events.

THEREFORE, LET IT BE RESOLVED that in the Graduate Student Senate Bylaws Article III, Section 4 (b.iii.1) be amended as follows:

Current Language: "1. Funding will be distributed equally among all approved applications

except when requested amount is less than award. In such case, the award

will equal the request."

Amended Language: "1. Funding will be distributed equally among all approved applications,

with those applicants that serve in leadership positions or present research

receiving an additional 15 percent above the base attendee or other

participant distribution."

Support for the Compensation of the GSS Vice President Starting in the 2010-2011 Academic Year

WHEREAS, Bowling Green State University Graduate Student Senate recognizes the significant time commitment of individuals serving as GSS Vice President, and

WHEREAS, Article II Section 2(c) of the GSS Constitution states that the GSS may "institute any measure or function deemed proper to the interest of the BGSU graduate student community," and

WHEREAS, Article III Section 4(a) of the GSS bylaws states that "GSS uses its budget for the accomplishment of the GSS mission as provided for the Constitution", and

WHEREAS, the position of Graduate Student Senate Vice President has traditionally served as an integral and essential component of the day-to-day functioning of GSS.

THEREFORE, LET IT BE RESOLVED that Graduate Student Senate supports the proposal of compensating the individual serving in the role of GSS Vice President starting in the 2010-2011 academic year, and

LET IT FURTHER BE RESOLVED that GSS will allocate a maximum of five hundred dollars to assist that individual's continued professional development, by means of financial reimbursement for conference or research travel. The GSS Vice President will receive up to the half the maximum designated amount from these funds each semester, as reimbursement for their professional development travel during the course of the academic year. The funds will be paid to the individual following the successful completion of the Vice President's duties, as defined by the GSS Constitution and Bylaws, at the end of both the fall and spring semester. The Vice President cannot apply for additional professional development funds through GSS.

b. Funding for Professional Development

- i. Eligibility
 - 1. Applicants must be currently enrolled graduate students within BGSU's Graduate College, registered for at least 6 credit hours, and in good standing with the Graduate College.
 - 2. Applicants must be graduate students in academic departments in good standing with Graduate Student Senate (GSS) at the end of the previous semester during the academic year. (Applicants from departments <u>not</u> in good standing with GSS at the end of the previous semester during the academic year will <u>not</u> be considered for FPD. Applicants are responsible for tracking their own department's status with GSS.) All departments will be considered in good standing at the beginning of the new academic year.
 - 3. Each eligible student is limited to one FPD application per professional development activity per semester.

ii. Application Process

A complete application will include the following information:

- 1. Applicant's name, P-number, applicant's academic department, contact information, activity details, total amount requested, and applicant's signature (including date) (cover page);
- 2. Description of the professional development activity;
- A detailed (line) budget to describe all anticipated and researched expenses for which funding is being requested and revenues (specifically from funds provided by a department or other organization); and
- 4. Printed documentation supporting the conference registration, lodging, and transportation costs for which funding is being requested. Proof of purchase or payment is <u>not</u> required at the time of application, only documentation of reasonable expected costs. This may include, but is not limited to, printouts of plane or hotel reservations, searches on travel sites such as Travelocity or Orbitz (with clear marking of estimated price or range of price), major hotel chains as well as conference registration websites.

iii. Funding Guidelines and Appropriate Use of FPD

- 1. Funding will be distributed equally among all approved applications except when requested amount is less than award. In such case, the award will equal the request.
- 2. FPD will be considered only for expenses related to transportation, lodging, and registration as well as dissertation, thesis, and other program requirements.
- 3. FPD will <u>not</u> be provided for meals, food expenses, or other social activities.
- 4. FPD will only be granted as reimbursements, with original receipts, within 30 days of travel.
- 5. Applicants are eligible for a maximum distribution of \$275 per academic year. Please note this is the maximum amount; actual allocation is dependent upon the number of applications and funding available within any given semester.
- 6. Applicants may only apply for FPD during the semester in which the activity will take place.
- 7. BGSU standards must be used in calculating expenses (i.e. current mileage rates, etc.), and current information is located at www.bgsu.edu/offices/business/page22084.html.
- All applications and proposed budget materials will be verified and considered anonymously by the GSS FPD Allocation Committee, chaired by the Treasurer.

- 9. Appeals of funding decisions will be considered by the GSS SEC.
- 10. Written appeals must be received by GSS within the timeline determined, prior to the due date of the application, by the GSS Treasurer: typically, six (6) days from the date the applicant receives notification of the original GSS FPD decision. Written decisions of appeals will be available to applicants in a timely fashion, following consideration by the GSS SEC.
