Position Description: The Department of Communication Sciences and Disorders at Bowling Green State University is seeking one tenure-track faculty member to contribute to the department's forward momentum. An individual is sought who will foster further development in educational, research, and clinical training in our undergraduate, master's, and Ph.D. programs. Our department's faculty members are engaged in a wide range of teaching and research activities, including doctoral mentoring, innovative pedagogies and the scholarship of teaching and learning, and national and international research collaborations. The department has ties with BGSU's J. P. Scott Center for Neuroscience, Mind and Behavior and many other departments and programs across campus. The tenure-track position is for the rank of Assistant Professor in Communication Sciences and Disorders, speech-language pathology or speech-language science emphasis, available August 2019. This is an academic year (nine-month) appointment with possible summer employment, if desired. Area of emphasis is open, and strong candidates in all areas are welcome and encouraged to apply. Some examples of specialties include, but are not limited to fluency, medical speech-language pathology, neurogenic speech and language disorders, speech science, augmentative and alternative communication, speech sound disorders, and/or related areas.

Primary Responsibilities: Responsibilities include teaching undergraduate, master's, and Ph.D. courses in areas of expertise; conduct research in areas of expertise; seek extramural funding; participate in related service, scholarly, and/or clinical activities, as applicable.

Qualifications: Earned Doctorate in Communication Sciences and Disorders or related field by August 2019. CCC-SLP and Ohio license (or eligible) preferred. Successful applicants must either have demonstrated or show strong potential for developing an externally funded research program.

Salary: Competitive and commensurate with peer institution levels for rank and position and in keeping with candidate experience and credentials.

Application Information: Applicants should submit curriculum vitae and letter of application that includes a description of teaching interests, research interests, and a personal statement detailing reasons for interest in the position. Contact information for three professional references. References may be contacted. Finalists will be required to submit an official transcript indicating highest degree earned. Bowling Green State University is a residential, comprehensive state supported university with roughly 19,000 undergraduate and graduate students. The city of Bowling Green has a population of just over 30,000 and is located in Northwest Ohio within close proximity of Toledo, Columbus and Cincinnati, Ohio. The Department of Communication Sciences and Disorders is one of ten departments/programs in the College of Health and Human Services. The Department offers a B.S., M.S., and Ph.D. in communication disorders. The master's program received CAA reaccreditation for 2011-2019. CDIS has approximately 106 undergraduate, 62 master's, and 8 doctoral and bridge students. It has 7 full-time tenure-track faculty members, 2 full-time non-tenure-track faculty members, 5 part-time clinical faculty members, and a full-time clinic director. The Department's Speech and Hearing Clinic is a vital part of

the program, providing opportunities for students to gain supervised experiences in clinical service delivery. The College of Health & Human Services incorporates 3 academic departments with numerous programs, including social work, food and nutrition, gerontology, public and allied health, and criminal justice. The College is growing, with new classroom and other facilities that were completed in 2016.
