

Assistant/Associate Professor Bowling Green State University Criminal Justice

Position Description: Bowling Green State University (BGSU) is seeking applicants for a tenure-track position in Criminal Justice at the Assistant or Associate Professor level starting August 2019. The Criminal Justice program is one of the fastest growing programs on campus and currently serves over 500 students. The program offers a BS in Criminal Justice, including a specialization in forensic investigations, a MS in Criminal Justice with both a face-to-face cohort and an on-line cohort, and a MS in Forensic Science with a specialization in Forensic Investigations. The Forensic Investigations degrees are closely tied to the Ohio Bureau of Criminal Investigation's new Crime Lab and the Ohio Attorney General's Center for the Future of Forensic Science. Criminal Justice is one of three programs in the Department of Human Services in the College of Health and Human Services.

Primary Responsibilities: Responsibilities include teaching at the graduate and undergraduate level in the criminal justice programs; establishing a record of high quality research and publication; student advising; supervising graduate students; participation in curriculum design; and providing professional service through community engagement and professional societies. Responsibilities also include participation in collaborative and cross-disciplinary teaching, research and service.

Qualifications: Candidates are required to hold a PhD in Criminal Justice/Criminology or closely related field. ABD candidates will be given consideration with evidence provided of completion of the PhD by the start date. A Juris Doctorate degree alone does not serve as a qualification for this position. Preferred candidates will have experience teaching some combination of introduction to criminal justice; victimology; corrections; race, class, and criminal justice; or ethics.

Salary: Competitive and commensurate with peer institution levels for rank and position and in keeping with candidate's experience and credentials.

Applicants should submit a letter of application and full curriculum vitae summarizing their suitability for the job, a description of their research plan, a statement of teaching experience/philosophy, contact information and contact information for three professional references. Finalists are also required to furnish official transcripts and are subject to a background check. **Application deadline: November 20, 2018**.

Bowling Green State University is a residential, comprehensive state supported university with roughly 19,000 undergraduate and graduate students. The city of Bowling Green has a

population of just over 30,000 and is located in Northwest Ohio within close proximity of Toledo, Columbus and Cincinnati, Ohio.
