

Dependent Enrollment at BGSU

F-2/M-2 Dependents of F-1 and M-1 Students can attend Bowling Green State University on a part-time basis and maintain their status in the United States by complying with the Federal Regulations listed in the Department of Homeland Security's Final Rule posted in the Federal Register on June 1, 2015 (full text posted [here](#)).

Procedures

1. Follow the admission process for attending BGSU.
2. Submit the following dependent immigration documents and this form to iss@bgsu.edu
 - a. Passport of Applicant
 - b. Form I-20 for the F-2 or M-2 Dependent
 - c. Visa of the F-2 or M-2 Dependent
 - d. Letter of Enrollment Verification from the F-1 or M-1 student's Home institution
3. Enroll in and complete the part-time courses.
 - a. Undergraduate maximum enrollment: 11 credit hours per semester
 - b. Graduate maximum enrollment: 7 credit hours per semester
