

## UNDERGRADUATE INTERNATIONAL STUDENT ON-CAMPUS HOUSING INFORMATION

(PLEASE NOTE: new international students will *not* be able to submit an on-line application a residence hall assignment until they have an active bgnet e-mail account.)

All undergraduate students are *required* to live on campus for the first four semesters of their studies at BGSU. In effect, this is a **two-year** on-campus residency requirement; students are committed to a full year contract (i.e., **both** Fall and Spring semesters) for each year.

New undergraduate international students are generally expected to comply with this regulation. Those international students whose full housing payment is not received by the deadline will be provided on-campus housing on a space-available basis.

Initially, new undergraduate international students must submit the **full semester housing fee** for one semester for their room and international student meal plan accommodations. They will be billed for the full fee for the second semester of their year-long room and meal plan contract when they register for second semester classes. The fee for the initial semester room and meal plan must be received by Ms. Lynn Huber in the BGSU Bursar's office on or before July 1 (for Fall semester) or November 1 (for Spring semester) in order to be assured of on-campus housing.

\_\_\_\_\_ Wire transfer. You can wire money to Huntington Bank, Bowling Green, Ohio 43402. The Routing Number is 044000024. For Credit To: Bowling Green State University, Account Number 01479702718. (Note your **BGSU ID number** on the form.)
