**Statement of Selective Service Registration Compliance**

On September 25, 1986, Section 3345.32 of the Ohio Revised Code became effective requiring that male students who are Ohio residents must register with the Selective Service or verify that they have registered with Selective Service in order to be considered in-state residents to attend Ohio public colleges and universities. Failure to comply with the requirement will result in assessment of the out-of-state surcharge for each ensuing term of enrollment until the student has complied with the Selective Service registration requirement. [If you are receiving Ohio-based financial aid, you will be required to complete the Office of Student Financial Aid's Selective Service form.]

Bowling Green State University and its male students are required to comply with the provisions of this law relating to verification. Please review the statements listed below and check the appropriate one.
