- V. Open Forum
 - a. Mr. Matt Haschak- Alert BG
 - i. I have been asked to speak about Alert BG, I am hoping at least everyone is familiar with what Alert BG is. I want to give you some awareness about the system, what it does, and what we are planning for in the future. Alert BG is a multimodal system that allowed designated university officials to send mass communications to campus community. They let us know if an emergency is going on. This was implemented in 2007. E2campus is what we use, and they have 800 plus schools on their system. The multimodal system is used by sending out one message and it is sent via text, e-mail, BGSU homepage, twitter, and Facebook. When an alert occurs they send out about 60,000 e-mails to all account users. This usually takes 1-5 minutes. The homepage changes and will remain approximately an hour unless Marketing and Communications decided they want to keep it. The University Facebook page gets a post, same thing with Twitter. There are 125 digital signs across campus, like the ones dining uses to display messages. Those automatically change as well.

Plans for the future, we are looking to desk-top notifications, public address system, and automatic dialing of on-campus phones. We will be implementing a new phone system this year. The text messaging side is the one we are focusing on, right now you have to go to the website to subscribe to this and I believe it lasts for two years. Right now we only have about 5,800 people in the alert BG text message system, and most of them are faculty. We are looking at an opt-out model, which means we automatically load your info into the system, but you can opt-out. This is a trend we are seeing in a lot of places, and they say this is something that has really picked up in the last year. The state of Texas passed legislation that universities are required to have an opt-out model. Ohio State may

have just gone to this as well. I don't have details on how we are going to do this, so the details on the execution are forthcoming. We talked about wanting to drive up the participation. Fortunately we haven't had to use it too much, we test it at least once a semester, but every time we do that I see how many people are in the system, and we want to drive up that participation. - 1. Durkit- I think it is a really good idea, with only 5,000 students it is important to get the information out in case something does happen.
- 2. Juzkiw-. Have you looked into people registering for the alert BG during orientation?
 - a. Haschak- That was part of the dilemma. We are looking very closely into student affairs, and that will be a big part of the next steps will be how to get all that information not only front freshman but from you all that have already been here.
- b. President Solis and Speaker Dzienny- Semester Presentation
 - i. Solis- This year we decided to do a recap, but also outline some goals that we have for the upcoming year. I wanted to talk about USG background, a fall semester overview, and the spring semester focus.
 - ii. Dzienny- as far as how our senate is set up students are represented by an at large, their residency, and their college. We also have our 4 committee chairs that are elected internally to make sure you have structure within the organization.
 - iii. Solis- When David and I took office we reformatted our cabinet. We created new positions, and moved some people around. Some of the positions we added really came into play this year. Residence Life was important with gender neutral housing, and it was also a direct connection to RSA.
 - iv. Dzienny- I think the communications between senators and committees couldn't be higher. We want to thank the student affairs committee for their effort, and I have seen a lot more issues and accomplishments thanks to this committee. The fly with a falcon program, new computers in the commuter lounge, the Roc-U DVD kiosk, and the added Charley award were all accomplished last semester. We have also completely reorganized the office and archives to make a more convenient work environment. We had 2 really strong resolutions, completely overhauled the bylaw and constitution.
 - v. Solis- On the executive branch the smoke-free campus letter. After further review, discussion, we decided to endorse the initiative but not outright, pending certain conditions. Operation Tiger and PCC was something we really wanted to touch on during our time here.
 - 1. Neely- Josh Chamberlin came to us with this idea about Operation Tiger, and now we have 100 percent post recycled paper in all residence halls. And PCC was something that was initiated by

Mazey, and it basically outlined goals to achieve carbon neutrality at the university.

- vi. Solis- Adam Preidis with RSA had a chance to be involved in St. Baldrick's, we had a team and were available to compete with them. We reformatted campus fest completely, updated everything, and we are still trying to make that social media push. When Neely and I came in we wanted to focus on the Master Plan, Green Initiatives, and retention. The health center canceled tonight, but they will be coming back later this month.
- vii. Dzienny- My platform goals were all about creating a strong and efficient senate. Looking more into this semester, I would like to see a strong senate turnover, we want to see a strong transition if we can give them all of the resources we have from this year, they will have a great start. I also want to keep caucus/development days, which I think have been key to finding issues that we want to focus on. As far as this semester, we want to see legislation about Alert BG because this is important to the students, the student safety, and the student voice.
- viii. Solis- Marketing and Communications, this is a new position which had a lot of success. The Get Involved fair is coming up and we need to continue to get our name out there. Social media is a big push, but also the BG news, our weekly meetings were advertised, and we need to keep striving as an organization to be transparent. Campus renovations we want to put under focus, because the campus is changing. With Greek Housing on the table, the rec center renovations, this campus is quickly forming into something new. We just want to make sure that the student voice is heard every step off the way. You have representation on a lot of the committees where everything is happening.
- ix. Dzienny- We also wanted to emphasize collaboration between committees, and we want to focus on campus engagement and public safety to keep our students safe.

i. I made an expenditure report for all of the expenses from last semester. I wanted to give you a few things from our budget- stipends, marketing, collaboration, operations, COSGA, incidentals, and a rollover section. We don't know what our rollover is going to be – about 3,000 maybe more- we really want to push collaboration. Something that really works is that we have a really fluid budget-we've used 2,000 dollars for operations so far (office supplies, food, things that make our operation go) so we will be probably moving some funds around. We plan on using a lot more of the marketing budget. Stipends is fixed, it lists that we've spent only a part of that money. We budget 8,000 dollars for COSGA, and we just have to pay for hotels- there is a good chance that we will be under budget. We have been using operating more and more, so the estimated budget

was around 46, 000 dollars. With what we are spending right now, we haven't used that much, so if you have ideas of how we can spend our money, we really need to do that because once we have these purchases I need to rationalize that to Dean Carr so if we want to have a budget like we had in the past we need to rationalize that.
