- a. Dr. Nicholas Espinoza Director, Falcon Health Center
 - i. Hello. Thank you for inviting me. First off, I'd like to say I'm Dr. Espinoza, your medical director. I have been involved in a lot of committees, and a lot of organizations. It's great to see you all here, doing your part. I'd like to keep this open, answer any questions you may have about the health center. The BG health center had been your point of care since the 1950's. We don't want to look any different, just offer you more services, and more availability. Recently, they are looking at how to expand our hours, more availability. We would like to move into that direction.

ii. Ouestions

- 1. Chair Juzkiw- I ran into a situation, where I was ill, and was turned away. Is there any possibility for walk-in hours?
 - a. Dr. Espinoza- Hope to have both a walk-in track, and an appointment track. There may be a delay. May be an hour wait. That's exactly where we're headed. We are on the leading edge of the learning curve. There may be a little lag.
- 2. President Solis- I know we met a few times, but can you tell USG about your role, and your role with BGSU? Just provide some context.
 - a. Dr. Espinoza-I do report both to the hospital, and BGSU. Through Dick Sipp, and Jill Carr. Being sensitive to student issues. Don't want to take people from the outside. It's not the right time to take outside patients. 50-50% contract between admin and care. Scrambling right now. Walking a blueprint, we're learning week by week, finding new ways of doing things.

- 3. Treasurer Johnson- I have a regular prescription, which was not on file at the new center. How has the transition been, bringing those records over?
 - a. Dr. Espinoza-Files must be maintained for 8 years. All that data must be brought forward, as if it were a new patient. Bring your information in. If it would be efficient, pass the word that if they want to pre-load that info onto their online portal, and put it on the registration sheets.
- 4. Treasurer Johnson- Could you elaborate on the online system
 - a. Dr. Espinoza-It's setup that you can access health information through your e-mail. Today, I had several patients who set up their portal, and received contact through a messaging system. There are aspects of scheduling that would benefit as well.
- 5. Vice-President Neely- How do you see the role between Wood County and BGSU?
 - a. Dr. Espinoza-Neither is going anywhere. I think it's very good. The person in my role has to answer t two bosses. It's like anything in business. They have two different missions, two different cultures, and it's our job to bridge that gap. I think it's been positive.
- 6. President Solis- When you track success, is there a way for students to give feedback, communicate with staff?
 - a. Dr. Espinoza-There's a master agreement between Wood County and the University, outlining the elements required: accreditation, patient quality, best practices. Those are reported quarterly. First meeting is in October. Another important element is student input. Want to do student surveys. We're not sure how yet. We want objective information. We want to fix problems, that's why we're here. We want to try to give kindness from front to back, and back out to the front.
- 7. Vice-President Neely- Is there any info the student body that the student body should know from us?
 - a. Dr. Espinoza-The availability of walk-ins. 3 full time physicians, really 3 ½, 3 nurse-practitioners. Adding another nurse. We realize that to implement the walk-in system we need another full time. We do want to take care of that.
- 8. Senator Timbrook- As a new student, I'm not sure about the old center. Are there other services now being offered.

- a. Dr. Espinoza- IV therapy room. Conventional services. Top 20 diagnoses list, provided to the university as requested. Part of our job is to help teach. That's what we're supposed to be doing. Teach how to avoid/manage situations as they come up.
- 9. Senator Darris- At the old center, I used the nutritionist. Those services are no longer available?
 - a. Dr. Espinoza-The hospital and the University are working on that, on who will provide those services.
- 10. President Solis- How are the facility operations going?
 - a. Dr. Espinoza-The facility is excellent. They really did a good job. There's two long hallways of treatment rooms. Possibly moving women's health upstairs. Create a circular path for exam rooms, flow of traffic. Move it upstairs to be more private, less traffic. Administrative decisions, dictated by money. I think it works well. Wide hallways allows for easy movement. Never seen rooms so tight.
