  - a. Elections Packet Danielle Parker
    - i. Parker- Going to discuss this one last time. Open to any friendly amendments.
    - ii. Please see attached.
    - iii. Debate
      - Durkit- The main question at hand is if you can lead USG without
        experience, or are required to be in this body for a semester. Brian just
        made a point that you wouldn't be able to walk up to dance marathon and
        say, "I want to be president". One way to assay this is to have this policy
        take effect in the fall.
      - 2. Post- Can you outline the election process?
        - a. Parker- If you are a senator, you would attend an information session. Give them a sales pitch, tell them what they can do, what is required. From there, they would submit a budget. From there, they campaign, and turn in paperwork saying what they spent the money on. We make sure we have their petition. Once

that's all clear, they're good to campaign. For right now, the requirement is just a year at the university.

- Juzkiw- We need to think about the person in those positions. President
  and Vice President are people that senators look up to. If the
  president/vice president don't have that experience, it will hurt
  development.
- 4. Puffenberger- I wanted to respond to Chair Durkit's comments. I think that having a semester of experience is very important. Those who want these positions will groom themselves for that. Those who want to take on that responsibility must be cognizant of that job. Our President and Vice President do a lot, and have a vital role. Not all institutions have this.
- 5. Dettrow- I think the word experience is flexible. Those who sit in the room might count that as experience. As well, a proxy could make the
- Timbrook- I think that instituting this rule now looks underhanded.
   Might look like USG is being discriminatory. I don't think we can institute that rule now.
- 7. Mazur- We can't instate a policy to restrict someone's opportunities without providing an opportunity. I do absolutely support USG experience. It's hugely important, and it's something the University invests money into. I don't think you can get the kind of experience from the outside. If we institute that now, people coming from the outside will not have their opportunity. It's not as simple as pushing it back.
- 8. Juzkiw- You mentioned proxies. The problem I see is that we don't take attendance for proxies and those in the lobby. I bring up the point that if someone truly wanted to make a difference, they would have come to USG sooner.
- 9. Puccio- This is something that we should either pass now, or scrap this part. If we were to pass this for a later date, we would be passing this off to the next senate. Also, it's going to affect everyone in some form. Every single one of you have completed a semester of experience. I would like to here your feedback.
- 10. Johnson- President and Vice President are paid positions, this is like a part-time job. When looking at resumes, you look for experience. It's not
- 11. Harris- There are senators who have been doing great work, but came in during the semester. How would we compensate for that?

- a. Parker- That's what this conversation is for. We can define experience. We can make it whatever you want it to be. I'm open to any friendly amendments.
- 12. Dudek- I agree with what is being said. As I stated last meeting, this is vital to this university. I propose an amendment. Create an appeals board to oversee petitions.
- 13. Chair Juzkiw moves to extend time by 20 minutes
  - a. Seconded by Chair Durkit

#### iv. Debate continued

- Senn- I completely agree with Senator Dudek. If you look at this from a
  business standpoint, CEO's can come from outside. I'm sure there are
  certain things that the Senator or Chairs know about the President/VicePresident positions.
- 2. Puffenberger- When we first talked about this, I suggested some sort of appeals process. There would be a concern about subjectivity. You would have to establish a standard. I would be concerned that this would create a whole other criteria to decide on. The marketing of it, campus needs to be made fully aware. Do we have enough time to make everyone aware.
- 3. Dudek- The vote of the entire senate is favorable is because....all this is doing is removing the generalization that if you are not in USG, you don't have the experience. I would think that the vote of affirmation should be 2/3 or 3/4ths. If this person doesn't have experience, we should reject them.
- 4. Webb- Another way to look at this is if we don't make the change, is to really dig into this process. Have them present, grill them for their experience. We've had debates. The debates have been not well attended.
- 5. Dettrow- I think that our organization is based around giving students a voice. It should be up to them. If they want to elect someone, it is their right. Ultimately, it is up to the student body.
- 6. Solis-There's a lot of good conversation around the table. As someone not coming back, there are some differing viewpoints. At the end of the day, it is up to the student body. As the president and vice president, you wear this dual hat. The decisions you make affect not only USG, but the entire student body. The senate should start working on this edit, instead of expanding out.

- 7. Neely- I'm in a strange position of being in the role. I think it's vital to allow the student body to keep their student body. I think USG experience is vital, but I think it is the student's responsibility to vote responsibly.
- 8. Webb- Friendly amendment. Change Section 5 to reflect the new Presidential spending cap.
  - a. Parker- I accept.
- 9. Dudek- There are how many members on the board?
  - a. Parker- Seven.
- 10. Dudek- This would be a better amendment.
- 11. Parker- I have a question. If the P&A board were to accept petitions for this, the time line would be very tight. My first information session will be February 17<sup>th</sup>. I don't want to push back.
  - a. Dudek- We will settle this tonight.
- 12. Durkit- Does this election packet contain the experience at this point?
  - a. Post-Yes.
- 13. Puccio- There have been a lot of great revisions. I think it's crucial for us to pass this tonight.
- 14. Juzkiw- In regards to the timeline, you are the timeline. If you do not allow it to take any time, then it won't. Having a system like that won't push back the system.
- 15. Puccio- I like the idea that Chair Juzkiw brought up. Maybe let them know at every info session. Maybe a deadline
- 16. Parker- The first info session is February 17<sup>th</sup>, last is the 26<sup>th</sup>. All must be completed by March 7<sup>th</sup>.
- 17. Puccio- Yes, have that be the final dealine for everything.
