V. Open Forum

- a. Mr. Michael Ginsburg Associate Dean of Students
 - i. Thank you for having me in this evening. We've been working this academic year on updating the Student code of conduct. Every 5-7 years, benchmark it against other universities. When we look at those, we look for ideas that other schools are using.
 - ii. Please see attached.
 - iii. In the review process, the review starts with a committee chaired by a faculty member (Phil Morrison), undergrad and graduate representation. I put together an ad-hoc student group for feedback. Next up is coming to you, presenting our ideas for changes. Then taken to the Student Affairs Advisory Board, where they can approve, deny, or recommend changes.
 - iv. Section 1: Wanted to match the non-discriminatory policy used by the university.
 - v. Section 2: Articulates when a person no longer is considered a student.
 - 1. Also defines what an incident report is. City reports, law reports as well.

- vi. Section 4: Adds language that deals with electronic acts of misconduct.
- vii. Section 6: What standard of proof the university should use. The standard of proof we use is "more likely than not". In the introduction section, want to clearly state that the burden of proof is "more likely than not".
 - 1. Added language concerning snapchat, other social media It is also a violation of sharing or storing the record is prohibited.
- viii. Section 6 Part B: Seperated into 5 components. When charged with the code, students often think they were charged with the entire section. If you are familiar with the Violence Against Women Act and Title IX, they have encouraged the university to add definitions.
 - 1. Harassment policy taken from many sources.
 - We looked at the local definition as well as other institutions.
 VAW act encourages universities to look at how stalking is criminally defined.
 - 3. Created a definition of sexual misconduct, made it a stand alone violation.
 - 4. Title IX has become a huge issue. Trying to become more compliant. policy language may have been lacking.

ix. Consent Definition

 In the last part, added in a section that says that "an individual must be of legal age to give consent", as defined by the state of Ohio.

x. Hazing

 Being requested or required to engage in actions that could be harmful to the health, welfare, or academic progress of the person. Hazing can inhibit progress in academics.

xi. Retaliation

- 1. Added retaliation as a specific violation, to become more Title IX compliant.

- xii. Section 6 Part C: Added language that prohibits the use of BGSU emails to send spam messages.

- 2. Using materials for the purpose of an intoxicants section added.

1. Hoped to make the language more clear.

xv. Section 8

- 1. Added in a section that clearly articulates how an investigation begins. What that first meeting will look like.
- 2. Kent State, Ohio State, victims retain the rights of a complainant even when the incident report is filed by a third party.
- 3. Every student is entitled to an advisor. Added

xvi. Section 10

- 1. Added who may be copied on sanction letters.
 - a. Those individuals must have a legitimate educational interest
 - b. Be a part of the sanctioning process

xvii. Section 11

1. Adds information on the process when an appeal is filed. Added the potential appeal outcomes.

xviii. Section 14

- 1. Added information on the Refund policy.

- 1. Chair Durkit- There is a two semester policy. Does that include that summer semester?
 - a. Yes, it does.
- 2. Chair Durkit- Does celebratory riot include rushing the field? Is that language lifted
 - a. It is possible. That is a criminal definition. This law was applied
- 3. Chair Durkit- The use of group charges. Is this becoming less of a problem? Becoming a real and tangible problem?
 - a. It is the hall directors' call. At least in first time, they are relying more on the conversation as an educational opportunity.

- 4. Chair Juzkiw- Would sanction letters include Greek presidents?
 - a. Students are asked to meet in person, let them know the outcome.
 - i. Juzkiw-Is there any way to add that for Greek Presidents?
 - 1. Does go to RSL staff.
- 5. Chair Juzkiw- In testing this, there wasn't any representation for International students?
 - a. Our GSS rep, Lingxiao Ge, was intentionally chosen.
- 6. Solis- What has your experience been when working with City police
 - a. We have a good relationship with the City police. Put the blotter online within the last two years. VP Carr was able to work on creating that role, so we can go through that blotter. Chief Connor insures that an officer is present in formal hearings.
 - b. There's a part of the hearing when they are asked "what do you think the committee should do", usually refers to the committees decision
- 7. Solis- I think the Joint Responsibility clause is tricky. When a student is saying no, isn't that the behavior we're promoting
 - a. It's a case by case basis, still have that conversation. In my mind, that investigation would most likely
- 8. Solis-
 - Can only go to a parent or guardian on second offense for alcohol, drug offenses
