- IV. Open Forum
 - a. Admissions with Director of Admissions Cecilia Castellano
 - i. I started here as a BGSU student and graduated in 1986 and have never left. I am originally from Dayton, OH and when I came here, my parents dropped me off and said because they wanted me to stay that I should come home for a while. I have been here since then, so can anyone give me a ride home? (laughs) I currently have one BGSU student in my home and I am very proud of her as well. I am also the new Director of Admissions, however, I have been working here for a long time and I probably helped in admitting everyone in USG right now. I am really

happy to be here, since I have never been here before. I would like to give you all a brief update on admissions right now as we head into Fall 2015. Just provide some background, we had 3364 students admitted in 2013, however, that went down to about 3331 in 2014. We have had a few increases, however, as we have had a slight increase in international students. Additional, the quality of our students has increased, which leads to increased retention. However, this means that Admission/enrollment goes down because of that quality. We currently have an enrollment goal for increasing our enrollment. I report every Monday on how Admissions is doing. I am used to being front and center. For Fall 2015, we are tracking significantly ahead than compared to 2013 and 2014. We expect to stay around 2013 in admission numbers. The quality is holding, which means a lot of applications are coming in and they are the right kind of applications coming in. We are also doing some new things for advertising for next year. We now have advertising in the Bengals football games. This is because we do not have a lot of students from the Dayton/Cincinatti area at BGSU. They are more familiar with Bowling Green, Kentucky. One of the things BGSU is doing is using President Mazey, since she has ties to Wright State University in Dayton, Ohio. We not only advertise at the Bengals stadium, but also a lot in that area. We are not ignoring primary markets such as Cleveland, Columbus, Detroit, and Michigan suburbs, and Chicago. And we are seeing improvements in Dayton/Cincy area. As a runner, I like to use a marathon analogy, where you start early and finish strong. So how can USG help? One of the things we get as positive feedback is how great and nice the students are. People are always saying how they met the nicest student in the Union, got directions, etc. I have taken my daughter to see other campuses, and you really just don't find the same atmosphere at other places like you do here. It's the day to day things of our students that really do help.

ii. Questions?

- 1. Sen Mazur: When talk about certain quality items like GPA, ACT, College Prep, what does that mean?
 - a. Most schools have a rigorous college prep track in Ohio.
 We are looking for that on transcript. Won't be admitted without. Opt-out. Looking for college prep. Also looking

for how rigorous course work. Need to have been in college prep.

- 2. President Koccheiser: What do you think has contributed to increase in applications?
 - a. Last year, I took this job as interim director in November. We implemented territory management and separate admissions events. Basically, we restructured the office. I have a coordinator of campus events and campus visitors. Counselors are responsible for specific territories, generating applications on top prospects. These cousnelors are now solely focused on that, generating applications and admitted students. In order to get you committed, I have to get you admitted. Right now, over 12% ahead from 2013 and 2014. We are already over halfway from goal I want.
- 3. RSA President Rose: My sister had applied and was accepted on same night at her school? Is this a new process?
 - a. Was she at Hillard? Or Lakewood? We call it on-site admission. It has been around for a couple years. Students come to an event with transcript and come and apply and we usually can tell on site if they would be accepted or not. Other schools do Decision Day, where students all come and find out if they are accepted or not to various area schools on site.
- 4. Chair Puffenberger: What kind of programs for non-traditional students?
 - a. We work closely with Barb Henry from Non-Traditional Student Services and partner together on some of the non-traditional items. We do work with those students. We have transfer visit days every month, waive fee for active veterans, transfer credits from service among other services. We are working for a new center for online study. The University is working on on-line, working through what they need for an online campus.
- 5. Sen. Bumbaugh: What are some of the biggest selling points for talking to high school students?

- a. We convey two messages. First, is the value of a BGSU education. In ratings and price for education compared to other schools, we have lowest net rate in Ohio. Engagement of students both in and out of class is very high at BGSU. We have Faculty in and out of the classroom, there are so many opportunities you'll get. Second, we are a large university with a small school feel. In addition, Everyone is excited for the forensic lab. Applications are way up for those programs and the new facility.
- 6. Sen. Watabe: What is the value of GPA, Test scores, and an essay. How does it compare to transfer student requirements?
 - a. Students not required for essay. GPA and Test score are valued equally for entering. We also look for a College prep curriculum. We take all these things into consideration. Transfer students are required to have 2.0 GPA from college and must not have been dismissed for student conduct. They need to provide college work. We do ask for high school transcript if they only attended one semester at their former university.
- 7. Sen. Khatz: Is Bowling Green a Common app school?
 - a. We are not. Miami, OSU, and USC are in Ohio. Therea re certain requirements for the Common App, however, they are changing their process for students, but BGSU not on that. We feel that a negative of the Common App is application to a lot of schools, a lot of paper and not a lot of intention. I'd rather not be on list of 18 schools for each student but 4-5 schools.
- 8. Sen Irvin: Since funding is now fixed for retention, is there an increase from funding?
 - a. Yes and yes. The state funding model used to be based on enrollment, based on the number of seats filled. Now its based on student degree completion and private hours. If student comes for full time, we get funded for that after the fact. Retention is a huge number that entering families and international students are looking at. That does more for

- admission rather than get paid to graduate students with a degree. I unfortunately am not the best at explaining it.
- 9. Sen Claywell: What are some ways you are looking to improve SOAR? How is the process going? Where are the evaluations taken from?
 - a. I am not sure. SOAR falls under the Dean of Students, so I will have to defer to Jodi.
 - b. Dean Webb: SOAR falls under Dean of Students Office.

 The point we are at is the Orientation Committee and we gather feedback from them. The program will have more student involvement and we're trying to better utilize the one day they are here. We have more time talking about that. We work closely with Admissions with getting students into the system.
- 10. Sen. Mullins: I am member of the College of Business and currently the only one in my college from Southeast Ohio. Is there is anyone who has southeast Ohio area assignment?
 - a. Where from? Jackson. You are the only student from Jackson in College of Business? Southeast Ohio is a tertiary market. We historically do not get students from that area. Five years ago, we deployed recruiters to all counties. After 4-5 years, it produced same results. We had to start looking at where was the best turnout for investment. We cover that area, but there's not a lot there. All schools have primary, secondary, and tertiary markets, and Southeast Ohio is one of our tertiary markets.
