 - a. Sarah Waters, Director of Residence Life

Some overview and updates in Residence Life will be mostly what I will be talking about this evening. This fall we have the majority of the new incoming class living here on campus. This has been up to 97% capacity at the start of this semester. The total number of on-campus students is currently at 6,223 residents. The bulk of our income comes from the room rates. This is our only source of income. There are a variety of expenses we have to meet, especially the \$8 million dollars we have to pay in debt fees and \$3 million dollars in utility fees with another \$3.6 million in custodial/maintenance fees. So there is a lot of money going out, so we have to compensate with the money coming in.

We have to keep our occupancy as high as possible. This has been a challenge from year to year as the number of incoming students has fluctuated quite a bit and it can almost be hard to predict who all finally comes to live on campus. With the opening of the new Greek Houses, we have an increased number of beds to fill and have to compensate to fill all of the empty beds they left in the resident halls where they stayed before. To help us, we closed a few hallways, especially in Harshman, to keep the occupancy level relatively high.

Another focus our office has is the retention rate from year to year. This past fall, we retained an 11.8% increase in students from the previous year. A factor of this being the increased number of commuter students with this incoming class.

Priorities for this year include: academic partnerships and charting a unified strategy for engagement and retention, opening the Greek Housing units and develop the Greek Housing community, create a long term strategic plan and work on starting the process of shutting down Harshman Hall.

With Harshman Hall permanently closing in May of 2017, we have to compensate for the loss of 600 beds. To work with it we may have the option to add maybe an off-campus apartment complex to raise our level of beds available to students. Priority for on-campus housing will be shifted toward first and second year students. Maybe even forcing students who have met the residency requirement of two years to seek other options of housing within the community. Ways to work with this include the off-campus housing fair.

Chair Burkholder: With the change in bed space, how will the rates be affected? Sarah: The rates will only rise about 2%. We will not hike our on-campus rate that much, though, neighboring off-campus housing might raise their rates when we close most of the bed-space.

Senator Smith: Will there be a potential new residence hall with the closing of Harshman?

Sarah: Yes, though, with the rate of construction on campus currently, we may have to wait until 2020 or even 2022 to see any finalized pieces. We want to evaluate what housing options students would benefit from the most, this includes either suites, traditional dorms, apartment style or even houses.

Senator Pamer:

Sarah: If you have to have the members to fill your spaces in the Greek Houses. Don't switch any Greek business tactics. So please, meet your housing requirement.

Director Cubberly: Will there be a renovation of air conditioning to the residents halls that don't have it?

Sarah: We have to do a return on investment to evaluate the possible cost. We have to evaluate the current economic status and review the condition of the halls for the final cost. I would like to see it happen, but it is certainly expensive. Once we have the evaluations finalized we will once again consider whether or not to pursue the option of adding air conditioning.

Senator Davis, Bryce: How will Res Life work with upper class students find off campus housing?

Sarah: We will do what we can but we are open to ideas.

Has Res Life been open to add free-standing AC units into their rooms?

We will have to evaluate our electrical load capacity and the safety issues associated with the AC units. Free-standing units need ventilation and a lot of the non-AC buildings are not made to necessitate the ventilation.

Has Res Life considered to transfer the single use restrooms where one person can use it at a time into an inclusive use bathroom where they can be used by either gender?

We have shifted a lot of those in the system, but if we missed a few spaces you can certainly send me the location and we can work with changing them.

Senator McMillen: Is there going to be a pay increase with overnight desk workers?

We have to evaluate a few pay models to even see if we have the budget to add a pay increase for overnight workers. Though, we are certainly exercising the idea. Senator Green: Is there transparency in the price of fees associated with damage costs?

Sarah: We have to cover the cost of the repair. A lot of times it is the labor cost. We don't look to make money on repairs. What the student pay is the bill for us to repair their damage.

Senator Goolsby: When you make changes for who gets housing, are first and second years going to get the priority on applications?

Sarah: Yes, the students who are first years and those transferring in will be considered the second years with the next upcoming year. With the exercised idea of apartments we need to maintain groupings of three to four students.

Senator Sakairoun: With all of the talk of reduced bed-space, will the university still be able to make emergency moves for roommates that need to be separated? Sarah: We have to be able to make emergency moves, especially with conduct policies. We have some wiggle room, but not a lot. Medical accomidations are another factor that can make it quite the opportunity to solve.

Senator Shakespeare: Will the university be concerned about the retainment rates with the loss of bedspace? Especially with upper classman being as to live off campus

Sarah: We are certainly not taking this likely, especially if we force students to seek leasings where they might be full.

Senator Snyder: How will they accommodate those who are granted the scholarships to live on campus?

Sarah: We would like to have space for you but that is more of a financial aid question.

President Dortch: What do you need from USG to efficiently reach students about the changing of housing coming up?

Sarah: First step would be for them to access our website or even send emails directly to our office. We haven't seen things coming at times and we really want to be proactive but are open to be reactive.

Chief Katz: Is the university seeking public-private partnerships to fund the new options of building resident halls?

Sarah: We have a public partnerships on campus such as Centential and Falcons Heights. We financed them becuase it was expensive to finance buildings in 2009 and 2010. The university opened up a separate foundation to facilitate the partnership and runs on university funds run out of our office. We took the route on our books as it comes back to the university. It isn't in our interest, but it depends on the amount of beds and space the building. In the end, it comes back to Ohio construction laws.

Director Cubberly: Is the quality of the greek housing a concern with residence life?

Sarah: No, the foundation and structure of the new houses is quite innovative. As long as we respect the facilities and use the commercial grade products available and work to repair any damages as soon as possible.
