- III. Open Forum- Sheri Stoll
 - a. CFO for Budget and Finances
 - b. Budget is heavily dependent on tuition and enrollment.
 - i. Internally, we have a chart that has a ten year enrollment rate, showing graduate and undergraduate enrollment.
 - ii. In the Midwest, the pool of 18-year-olds has been steadily declining. Not to mention, the pandemic hit the trend hard too. Potential undergraduate students did not want to go to school.
 - iii. For graduate students, the numbers go up because there's an economic decline.
 - iv. When we have lower undergraduate numbers, we get a few less million dollars in revenue.
 - v. This is an issue because enrollment has the biggest impact on Ohio's funding for us.
 - c. Fiscal year starts July 1 2025 June 30 2026.
 - d. Retention progress, specifically freshman to sophomore progress
 - i. We only receive funding from the state with outcome progress.
 - 1. To put it simply, they go through how many courses and graduation rates (along with a lot of other things) to figure out how much funding we get.
 - BGSU has been working on its retention rates to get that rate higher. If BGSU wants to move to the top tier academically universities, it needs to get over the 80% retention rate and keep it.

- a. It's incredibly difficult, considering we've been at around 77% and slowly moved up to 80% for 2023. We'll see how it goes for 2024
- e. Ohio has a 2-year budget. The governor has introduced the next state budget.Many of this pertains to state financial aid
 - i. Introduced by the governor very early February. He proposed it for fiscal years 2026 and 2027
 - 1. Provides flat funding in state share of instruction for both years
 - a. As BGSU retention and performance improves, this could mean getting more funding from Ohio
 - b. The state budget does not get bigger. That means we get more money while another university gets less money
 - c. The House may be looking to do something larger than zero, but there's no promises
 - 2. Allow tuition increase for incoming freshmen class (36-month average increase)
 - a. Since the Falcon Guarantee, this only effects the freshmen class
 - 3. Provides 12% increase in OCOG in FY2026: Reduction of 7% in FY2027
 - a. When this happens, it generally only impacts the incoming freshman. Will affect a significant number of prospective students, and they are working with the House to potentially get that change
 - 4. Provides 107% increase in Governor's Merit Scholarship in FY2026; provides 49% increase in FY2027
 - a. It applies to the top 5% of any Ohio high school. The governor has a massive increase for these, probably to account for the potential increase in the interest in it
 - 5. The Department of Higher Education only got 1% increase in both FY2026 and FY2027

- f. Campus Master Plan 2024
 - i. Explains the major roadmap over the next 12 -15 years of major plans and initiatives happening within that time frame
 - ii. Founders: building upgrades starting in summer of 2025
 - 1. Host of building system upgrades. Mostly plumbing and humidity related issues.
 - Will be executing summer projects for the next five years (only during the summer). Can't take Founders fully offline because it's too important for housing.
 - iii. Kriescher: chilled water lines starting in the summer of 2025
 - 1. Because of enrollments they cannot take it fully offline, so it will be done in phases as well
 - Sundial / Phase One of Kreischer will begin planning and designing during early 2026
 - iv. Summer projects will consider as well: roofs (mostly Fine Arts building & Ice Arena), parking lots, sidewalks, and other outdoor spaces.
- g. Q: We have an Advocacy Day. How should we approach legislators about S.B.
 - 1.0, specifically about the budget?
 - i. A: As the future of the state of Ohio, remind them of this. We will be the people who support Ohio in the long run. If we do not get invested in, then the future of Ohio will struggle.
 - ii. A: Ohio has always been at the forefront of retention of the future, and we are still being considered because of our future workforce. We need to remind the legislators that universities are incredibly important at preparing the next workforce as well as the economy in Ohio too.

 - 2. Lot of legislative research. When your representative is interested in something, you might do research on it
 - 3. A lot of writing, such as press releases, testimonies, and all writing related for legislations and whatever your representative needs

- vi. Q: Do you get to choose which representative you work with?
 - 1. A: You declare what party you will be with. Then you will be internally placed from there, hopefully with someone who is the rep for the interests you have
 - 2. A: There are 24 Fellows in a cohort. 22 are partisan positions and 2 that are not.

 - 1. A: It's a full-time job. You don't have to work or go to grad school at the same time. You should probably focus on the Fellowship if you get this career.
